Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

Item 1 – The following are responses to Requests For Information:

Please provide the specification for Bid Item SP-921-703-200 Bike Lane Separator.

The Bike Lane Separator item is to be used for quick-build material bike lane separators that include various products on the market that are to be determined during each projects design activity under the contract, subject to shop drawing approvals during construction. Products intended to be furnished and installed in this pay item include but are not limited to the following products: TreetopProducts bike lane separators, Zicla zipper curb, and Impact Recovery Tuff Curb XLP.

- SPT-2.17 As Built Plans: Are as built plans required for milling and resurfacing projects or only projects where new construction occurs?

Signed and sealed As-Built Plans are required for all projects.

- SPT-3.03 Project Sign: The specifications include a detail of the project sign (pages SIGN-1, SIGN-2), but SPT 3-03 indicates Not Applicable. Please confirm no project signs are required.

No project signs are required

- SPT 3-07 Temporary Traffic Striping: "Payment for temporary traffic striping or reflective markers used by the contractor will be made under payment line item 5 and 6". Items 5 and 6 appear to be Clearing and Grubbing, and Removal of Existing Concrete. Please clarify.

The language "Payment for temporary traffic striping or reflective markers used by contractor will be made under payment line item 5 and 6" is an error and shall be removed. Painted pavement markings under pay item 0710-90 shall be paid as a lump sum as outlined in the FDOT basis of estimates.

- (Page P3) Bid Item 0710 90 "Painted Pavement Markings Final Surface": This item is currently shown as a LS Item. Please clarify.

This pay item is to be paid as a lump sum item per task work order. The estimated price of this lump sum shall be determined utilizing the quantities of the permanent thermoplastic parmkings under the 711 pay items that require temporary painted pavement markings prior to the thermoplastic installation.

- (Page P4) Bid Item SP 921-703-200 "Bike Lane Separator, Furnish and Install" (350 EA) No reference to this item is included in the project documentation. Please provide a detail for this item.

The Bike Lane Separator item is to be used for quick-build material bike lane separators that include various products on the market that are to be determined during each projects design activity under the contract, subject to shop drawing approvals during construction. Products intended to be furnished and installed in this pay item include but are not limited to the following products: TreetopProducts bike lane separators, Zicla zipper curb, and Impact Recovery Tuff Curb XLP.

- Please provide specifications for 523-1-3 Patterned Pavement, Vehicular Areas – Green Bike Lane.

Specification for pay item 523-1-3 is per the FDOT basis of estimates.

- Page SPT-25 of the Specific Provisions section SPT-20-1.2 under cold milling states that the salvaged material from this project shall remain the property of the City of Tampa. Just want to verify that the City is retaining ALL MILLINGS from this project?

The City reserves the right to require that salvaged millings be delivered to the City's storage location identified during the project, if this right is not exercised, the contractor shall lawfully dispose of millings in a manner determined by the contractor.

- Does the City have a projected number of work orders anticipated under this contract? If so, how many?

There is no predetermined number of work orders.

- How will Mobilization and MOT be paid for under this contract? Will the contractor receive a set portion per work order, or will payment be proportional to the size of each work order?

Payment for mobilization and MOT will be paid proportional to the size of each work order.

- Can you please clarify the intent of SPT-9.07 on sheet 87 of the project specifications. It states: USE OF RECLAIMED ASPHALT: - Not Applicable Does this mean RAP will not be permitted in the asphalt mix designs used on this project?

All asphalt mix designs shall be per SPT-9.06 Pavement Mix Designs and must be approved via shop drawings by the Engineer of Record.

Item 2 - Sheet SPT-28 (pg 97/113) Revise the existing language in the SPT-21.3 Experience: as follows:

a. "Bidders must submit with their bid a minimum of five (5) Full Depth Reclamation (with emulsion and cement blend stabilization) project references from a City, County, or DOT in the State of Florida, that have been completed within the past five years."

Item 3 – Replace page P-4R with P-4-R2
