- Item 1: Existing Cable Length Clarification: Contractor shall provide the cost of the transformers specified in the bid documents. For bidding purposes, it is assumed that the existing cable length is sufficient to connect to the new transformers. In the event the existing cable does not have the required length to reconnect to the new transformers, contingency monies, included in bid, will be used to purchase any cable extensions required.
