ADDENDUM 1

Contract 17-C-00010 Bayshore Boulevard Enhancement, Phase III (from Gandy Blvd. to S. Howard Ave.)

Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

Item 1: Specifications, Specific Provisions, Add to page SP-5, after SP-2.17, the following:

SP-2.18 TEMPORARY WORK STOPPAGES

The Contractor shall temporarily discontinue all construction activities from, and including, Thanksgiving Day through the following Sunday, and December 24 through January 2.

Prior to temporary work stoppages, all streets shall be restored to permit access to all businesses and residences and to allow ingress and egress. The Contractor shall maintain all streets at this condition level for the duration of the shutdown period.

All equipment, except that used for excavation and well pointing, and all materials including, but not limited to, manhole structures, pipe, and stockpiled material shall be removed to either the Contractor's storage lot or to a location outside the project area as approved by the Engineer.

All costs associated with furnishing labor, equipment, temporary pavement restoration, demobilization, mobilization, signage, barricades, clean-up, security, and any other incidentals required to accommodate the Thanksgiving, Christmas and New Years' Holidays shall be included in the project mobilization bid item, and no additional payment shall be made therefor.

The Contractor will also be required to accommodate the following special events:

Saturday, December 09, 2017	Onbikes Winter Wonder Ride
Saturday, January 20, 2018	Gasparilla Children's Parade
Saturday, January 27, 2018	Gasparilla Pirate Fest
Saturday, February 24, 2018	Gasparilla Distance Classic
Sunday, February 25, 2018	Gasparilla Distance Classic

Site safety shall remain the Contractor's responsibility; during each of these periods all areas within the project limits must be restored to a safe condition, including but not limited to, temporary pavement and sidewalk, as required, to provide a safe and smooth impervious surface for the event. All construction equipment must be removed from the site the day before each of the events. No additional compensation will be paid for any temporary pavement or de-mobilization/mobilization. Any costs associated with this work will be included in the project mobilization bid item.
