Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

Item 1: Instructions to Bidders I-1.05, in the second paragraph, Change "192" to "280".

Item 2: Add the following to the Specific Provisions section after SP-9.09:

SP-9.10 CURB, GRANITE (INSTALLTION ONLY)

The Contractor is responsible for the pick-up and delivery of the granite curb. The granite curb is located at the City of Tampa's 34th St Yard, 116 South 34th St., Tampa, FL 33605. A forklift will be needed to load/unload the truck. The Contractor shall obtain prior authorization from the Engineer, and shall schedule with the Engineer the pick-up of the granite curb.

Payment shall be full compensation for all work, equipment, tools, labor and any incidentals required for completion of the work.
