

#### SIGNALIZATION GENERAL NOTES:

- 1. ALL MATERIALS AND INSTALLATIONS SHALL BE IN ACCORDANCE WITH THE FDOT STANDARD PLANS FOR ROAD AND BRIDGE CONSTRUCTION DATED FY 2021-22, FDOT STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION DATED JULY 2022, AND THE CITY OF TAMPA'S GENERAL INFORMATION PACKAGE FOR TRAFFIC SIGNAL CONTRACTORS.
- 2. THE LOCATIONS OF UTILITIES SHOWN ON THE PLANS ARE APPROXIMATE.
  PRIOR TO DIGGING, DETERMINE THE EXACT LOCATIONS OF ALL UTILITIES THAT
  MAY BE IN CONFLICT PRIOR TO ORDERING SIGNAL POLES.

- 4. CONTACT THE LOCAL POWER COMPANY AT LEAST 30 CALENDAR DAYS IN ADVANCE FOR ASSISTANCE IN PERFORMING ALL NECESSARY WORK UNDER POWER LINES. SUCH WORK SHALL INCLUDE, BUT NOT BE LIMITED TO THE INSTALLATION OF SIGNAL POLES.
- 5. SUBMIT THE AS-BUILT PLANS TO THE ENGINEER FOR APPROVAL PRIOR TO THE 48 HOUR TEST. UPON THE 48 HOUR TEST, THE ENGINEER SHALL PROVIDE AT LEAST ONE COPY OF THE FINAL AS-BUILT PLANS TO THE CITY OF TAMPA AND ONE COPY TO DISTRICT TRAFFIC OPERATIONS.
- 6. FOR A LISTING OF UTILITY OWNERS, SEE ROADWAY SHEET No. UT-18.
- 7. NOTIFY TRAFFIC ENGINEERING AT 813-274-7358 AT LEAST TWO FULL BUSINESS DAYS BEFORE MAKING ANY ADJUSTMENTS OR MODIFICATIONS TO ANY COMMUNICATIONS. ALL EXISTING I.T.S. DEVICES SHALL REMAIN OPERATIONAL THROUGHOUT CONSTRUCTION. ANY DAMAGE CAUSED BY THE CONTRACTOR THAT MAY INTERRUPT THE OPERATION AND/OR CONNECTIVITY OF THESE DEVICES WITH THE CITY OF TAMPA CONTROL CENTER SHALL BE REPORTED IMMEDIATELY AND RESTORED TO IT'S ORIGINAL CONDITION AND OPERATION WITHIN 48 HOURS AT NO ADDITIONAL COST.
- 8. ALL FIELD WIRING SHALL BE NEATLY BUNDLED AND CLEARLY IDENTIFIED WITH PERMANENT LEGIBLE, WEATHER-PROOF TAGS THAT ARE SECURELY ATTACHED TO EACH CABLE. THE TAGGING SYSTEM PROPOSED SHALL BE SUBMITTED FOR APPROVAL WITH THE OTHER EQUIPMENT SUBMITTALS REQUIRED FOR THIS PROJECT.
- 9. NOTIFY THE CITY OF TAMPA SIGNAL SHOP (813-274-3101) AND FDOT DISTRICT SEVEN TRAFFIC OPERATIONS (813-975-4216) AT LEAST 48 HOURS IN ADVANCE OF TURNING ON A NEW OR MODIFIED CONTROLLER CABINET ASSEMBLY.
- 10. GROUND RODS CAN BE WITHIN THE PED SIGNAL OR SIGNAL PEDESTAL FOUNDATION, OR WITHIN THE PED SIGNAL PULL BOX WITHIN TEN FEET OF THE PED POLE. GROUND RODS MUST BE ACCESSIBLE FOR INSPECTION.
- 11. DAISY CHAINING OF SIGNAL CABLE AT SIGNALS OR POLES IS UNACCEPTABLE.
- 12. SIGNALIZATION PULL BOXES AND COVERS MUST INCLUDE THE RAISED LOGO "TRAFFIC SIGNAL". INTERCONNECT PULL BOXES AND SPLICE BOXES MUST INCLUDE THE RAISED LOGO "CITY OF TAMPA FIBER OPTIC".
