**BID OPENING:** 1:30PM, Tuesday, October 24, 2023 **ESTIMATE:** \$1,820,000 **SCOPE:** The rehabilitation of approximately 18,174 linear feet of 8-inch, 643 linear feet of 10-inch, 275 linear feet of 12-inch, and 1,205 linear feet of 18-inch diameter gravity sewers with a cured-in-place pipe liner and rehabilitation of 76 manholes. Services include detuberculation, cleaning and inspection, sewage bypass pumping, re-establishing service connections, maintenance of traffic, lateral grouting, manhole rehabilitation and surface restoration as necessary.
