ORDINANCES IN CONFLICT THEREWITH; PROVIDING FOR AN
EFFECTIVE DATE.
WHEREAS, the City of Tampa Code of Ordinances, Chapter 15, Parking, Section 15-
104, Residential Parking Permit Only Area, establishes regulations for residential parking permit only areas within the City of Tampa; and,

establishes boundaries for the City's residential parking permit only areas; and,
WHEREAS, the City of Tampa Parking Division, upon meeting with and receiving
input from the community, recommends that the parameters defining the residential parking permit area be amended to include certain streets located in the Ybor City District; and,
WHEREAS, it is in the best interest of the City to amend Chapter 15, Section 104(b)
of the City of Tampa Code of Ordinances; and,

Palm Avenue; N. 20th Street, between E. 12th Avenue and E. Palm Avenue; E. 11th Avenue, between N. 20th Street and N. 21st Street: E. 12th Avenue, between N. 19th Street and N. 21st Street. When determining a residential parking permit only area, the area shall include both sides of the street, drive or avenue, listed as a boundary unless the area description clearly indicates to the contrary." Section 3. That all ordinances and conflicts herewith are appealed to the extent of any conflict. **Section 4.** That if any part of this ordinance shall be declared unconstitutional or invalid by a court of competent jurisdiction, the remaining provisions at the City of Tampa's election shall remain in full force and effect. **Section 5.** That this ordinance shall take effect upon becoming a law.
