#### **KEY ACCOMPLISHMENTS**

**T-REX:** The Transportation Expansion Project, referred to as T-REX, was a \$1.7 billion dollar transportation investment between Downtown Denver and Denver South.

The project added an additional lane in each direction along 17 miles of I-25 between Broadway and Lincoln Avenue in Douglas County and built 19 miles of double-track light rail. The expansion was finished 22 months ahead of schedule and under budget. The project has greatly improved transportation options for commuters in the Denver area.

FASTRACKS: The RTD FasTracks Program is a multi-billion dollar comprehensive transit expansion plan to build 122 miles of new commuter rail and light rail, 18 miles of bus rapid transit and 21,000 new parking spaces at light rail and bus stations.
