October 21, 2009 was a great day in East Tampa – we named the Community Lake at Dr. Martin Luther King Jr. Boulevard after Robert L. Cole, Sr., and later renamed the Fair Oaks Community Lake after Herbert D. Carrington, Sr. It was so inspiring to see so many East Tampa residents join together to honor these two men who dedicated their lives to improving our community.

During the two dedication ceremonies, I saw how our current efforts to revitalize East Tampa are actually building upon the

work of generations of East Tampa residents who have worked to build a better life and a safer neighborhood.

In this newsletter, we highlight some important neighborhood investments that have been made possible through TIF revenue such as the \$11 million North 22nd Street enhancement project that will start construction in March 2010. In addition to TIF funded projects, we are investing \$12 million in Utility Capital Improvement Program (UCAP) funds to improve water pipes in the area. We also highlight some of the private sector investment that is continuing in East Tampa - a sign that even in these challenging economic times, East Tampa remains a sound investment for the future of our city.

I appreciate the members of the East Tampa Community Revitalization Partnership. Your dedicated leadership continues to serve the community well and I thank you for your efforts toward the positive redevelopment of East Tampa. Together, we continue to build upon the strengths of the East Tampa community making it safer, more attractive, and economically vibrant.

City Receives \$400,000 Grant

The City of Tampa received a \$400,000 EPA Community-wide Brownfield Assessment Grant. This grant will be used to conduct environmental site assessments. The East Tampa Development staff will assist eligible participants to redevelop sites that have environmental challenges with funds made available from this grant. The financial assistance will help defray the cost of required Phase I and Phase II Environmental Assessments of petroleum contamination and hazardous substances sites.



Enhancing Infrastructure and Quality of Life



The beautification of North 22nd Street will consist of three phases. Phase I will be from Dr. Martin Luther King Jr. Boulevard to Lake Avenue and will begin next summer. Phase II will be from Lake Avenue to 23rd Avenue, and Phase III will create a roundabout where 21st Avenue and 22nd Street meet. The City is acquiring real estate to eventually encourage quality redevelopment along this corridor.

Sidewalks leading to local schools including James, Williams, Gary Adult,

Lomax, Ferrell, Middleton, Edison, Lockhart, Young and Orange Grove were installed in order to provide for the improved safety of children walking to and from school. TIF revenues allowed for the development of these sidewalks at a cost of \$450,000. An additional \$25,000 of TIF funds went to the repair of older sidewalks throughout East Tampa.

In addition, over 40 blocks of neighborhood streets were resurfaced in the Rainbow Heights community. The streets surrounding the Cyrus Greene Recreation Complex and Young Middle Magnet School were repaired and resurfaced. The street improvements were funded by \$600,000 in TIF funds.

Spotlight on East Tampa Businesses

Ella's Restaurant, located in Southeast Seminole Heights at 5119 North Nebraska Avenue, is a wonderful addition to East Tampa. The restaurant features an eclectic menu including Kansas City style barbecue. The restaurant is open Tuesday through Sunday for dinner.





Splash N' Dash, located at 3500 East Hillsborough Avenue, is a 24-hour selfservice car wash with a new state-of-the art touch free automatic washer. The East Tampa Division provided fast-track permitting to help assist in the re-opening of the car wash.

East Tampa Community Receives Two Awards

On March 24, 2009, the Hillsborough County Commission presented to the East Tampa Community Revitalization Partnership (ETCRP) two awards. The first was the Most Successful Special Event Award honoring the Aesthetics and Beautification Sub-Committee for coordinating a successful "Tree Lighting" program for school children, their parents, and members of the community.
