The Drew Park Stormwater Improvement Project is now moving forward in phases. The Henry Avenue Pond expansion was completed in December 2012. Construction of the Grady Avenue improvements began November 2012 and is projected to be completed in January 2014. FY09 funds in the amount of approximately \$525,000 will be used toward Grady Avenue stormwater and streetscape construction. The \$15.9 million Lois Avenue stormwater, utility and streetscape improvements project is under construction. Drew Park TIF funds in the amount of \$1.2 million will be used to fund the streetscape and other improvements.
