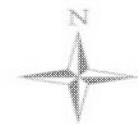

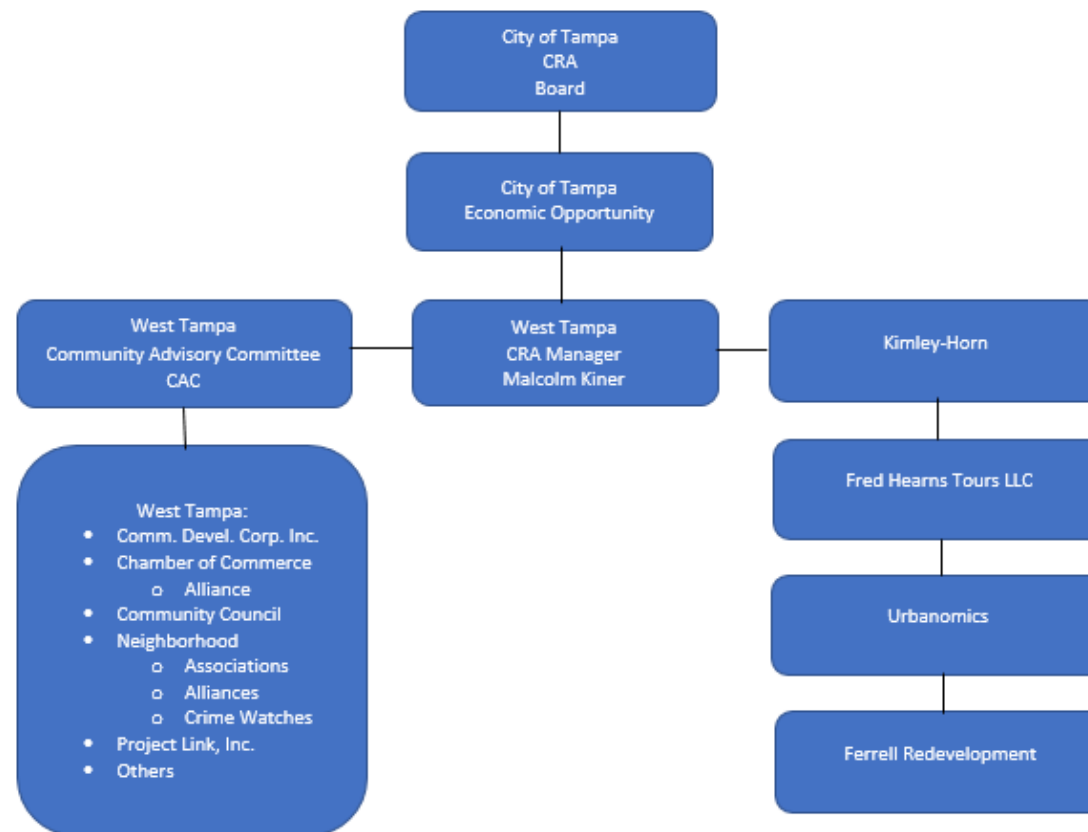

Project: Green Spine Cycle Track

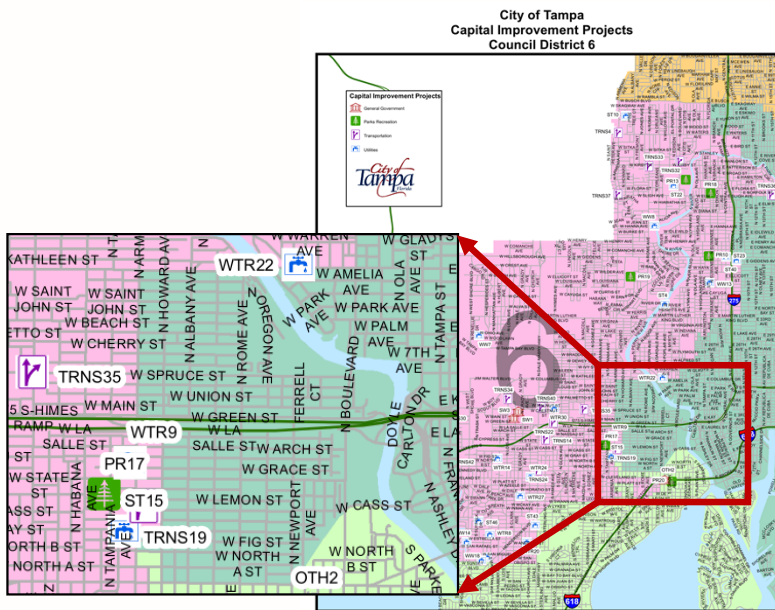

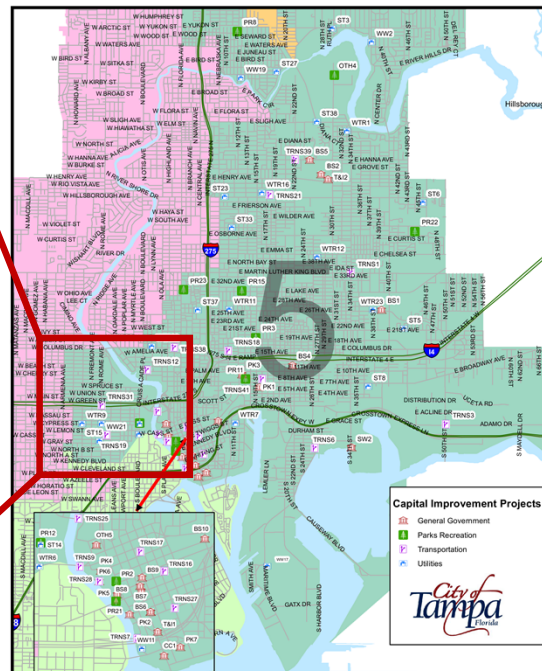
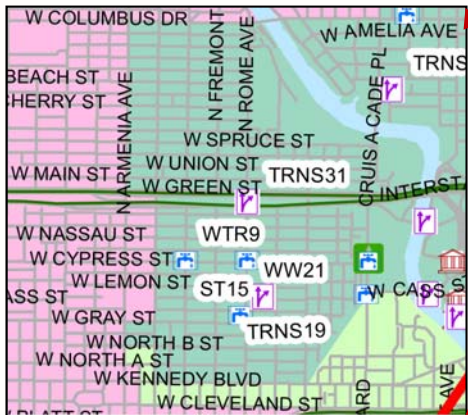

Tax Increment Financing (TIF)

Potential West Tampa Sources of Tax Increment Revenues

- **Growth of Base Taxable Value:** \$274.6 million base increasing @ 2% per year.
- **West River Development** (1,636 residential units and 177,000 square feet of commercial space): Estimated initial taxable value of \$272 million with a 15-year buildout. Assume equal annual increments of development with a conservative 2% annual increases in value.
- **Other Market Supportable Development:** Assume \$5 million in new taxable infill development and redevelopment annually, increasing in value by a conservative 2% per year.

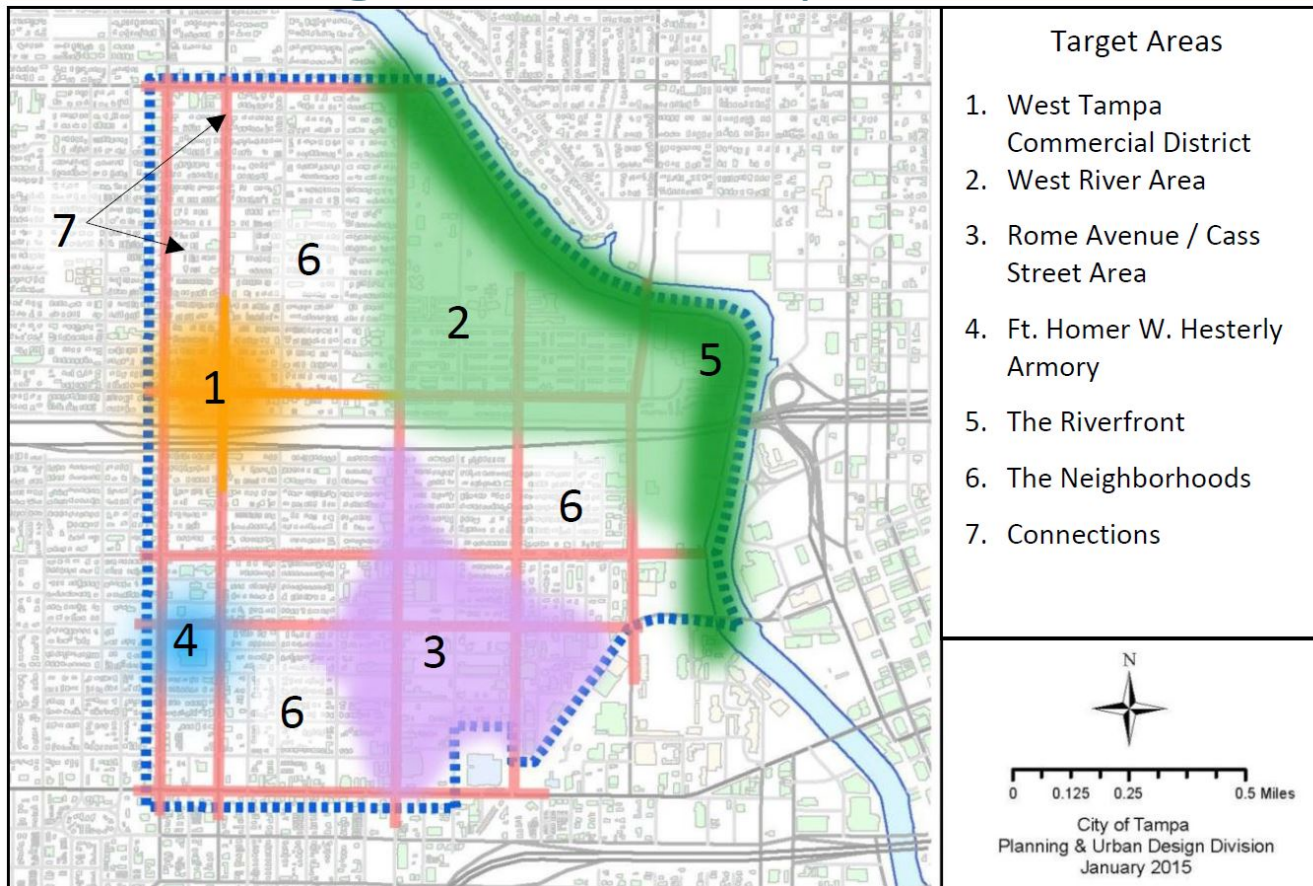

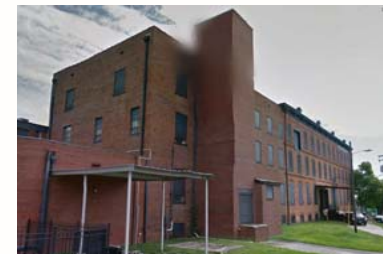
