ORDINANCE NO. 307.

An Ordinance for the Purpose of Reorganizing the Fire Department of the City of Tampa, and Placing the Employees Thereof upon a Basis of Merit and Otherwise Regulating the Conduct and Government of the Same.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TAMPA:

Section 1. Save as to the Chief of said Department, who is appointed under the provisions of the City Charter, all appointments therein shall be made according to merit and fitness, to be ascertained, so far as practicable, by examinations which shall be competitive.

Section 2. No person shall be employed in said Department who shall not have furnished satisfactory evidence, as hereinafter provided, in regard to character, physical manhood, and age, and who shall not have passed a satisfactory examination in speaking, reading and writing the English language, and who shall not have disclosed his fitness for such employment upon examination as to the special and technical knowledge required by such employment; but this examination as to special and technical knowledge shall not apply to those employees in said Department at the time of the passage of this ordinance, provided they possess the other qualifications required.

Sec. 3. The Committee on Water Works, Fire Protection and Electricity shall be and the same is hereby constituted a Commission for the purpose of conducting the examinations herein provided for, and the Chairman of said Committee shall be the Chairman of said Commission, and in the conduct of said examinations the Chief of said Department is required to assist, but he shall have no voice in the preparation of the eligible list from which appointments are to be made.

Sec. 4. Within ten (10) days after this ordinance goes into effect the said Commission shall meet in the Council Chamber of the City of Tampa and shall at said time conduct the examinations herein provided for as to all those who have made application for employment in said Department, but preference in appointment shall be given to those who are employed in the Department at the time of the passage of this ordinance, providing they otherwise come within the provisions hereof, and the next in order of preference shall be such former employees in said Department who retired from its service voluntarily, and the said Commission shall sit from day to day until said examinations have been completed.

Sec. 5. The said Commission shall give five (5) days' notice (hour and day) upon which it shall convene for the purposes mentioned in the preceding section, and all persons who are otherwise eligible shall be permitted to stand the examinations, providing their applications have been filed with the Chief of the Fire Department on or before two (2) days preceding such examination.

Sec. 6. No person shall be eligible for employment in said Department who is not a citizen of the United States, or who has ever been convicted of any crime and not restored to civil rights, and who shall not have resided in the State six (6) months, or in the County three (3) months, or in the City one (1) month; and all applications must be not less than five (5) feet and six (6) inches in height and weight not less than one hundred and thirty-five nor more than two hundred and five (205) pounds.

Sec. 7. That the City Physician be and he is hereby made a member of said Commission for the purpose of conducting a physical examination of each applicant, and no person shall be eligible to appointment in said Department who does not pass said physical examination to the satisfaction of the City Physician.

Sec. 8. Each applicant shall, at the time of filing his application with the Chief of the Fire Department, also furnish as references for character the names of at least three responsible business men in the City of Tampa, and his application shall be in the form heretofore prescribed and now being used in said Department.

Sec. 9. After said examinations have been held the Commission shall take charge of the examination papers and shall rate the applicants according to the Manual of Examinations prescribed by the United States Civil Service Commission as a schedule of examinations for the spring of 1903, in so far as the same is applicable and not in conflict with the provisions of this ordinance, and it shall be necessary to obtain an average per centage of seventy (70) per cent. to be eligible for appointment under the provisions of this ordinance, and rating the maximum per centage at one hundred (100), moral character shall count as twenty-five (25) per cent., physical condition as twenty-five (25) per cent., practical and special knowledge as twenty-five (25) per cent., and knowledge of the English language as twenty-five (25) per cent., but as to those who by the provisions herein are not required to pass the examination upon special and practical knowledge, the physical condition shall count as fifty (50) per cent.

Sec. 10. When all the applicants have been rated as herein provided for, the Commission shall prepare an eligible list of all those who have obtained an average per centage of seventy (70) per cent, graded according to the respective merits of each applicant, and said list shall be certified to the Chief of the Fire Department, and the said Commission acting as a Committee of the City Council upon Water Works, Fire Protection and Electricity shall at the same time designate the number of men to be employed in said Department, and from said eligible list the Chief of the Fire Department shall make the appointments and report the same to the City Council, and in making said appointments he shall make them in rotation commencing with the first name appearing upon said list.

Sec. 11. The willful deception of an applicant in matters pertaining to his examination, and the furnishing or receiving of information to or from others, pertaining to said examination, or any other conduct unbecoming a gentleman while said examination is being conducted, shall disqualify any applicant for appointment in said department and any applicant guilty of any such conduct shall not have his name placed upon the eligible list.

Sec. 12. Whenever a vacancy occurs in said Department, either by death, resignation or otherwise, the Chief of the Fire Department shall fill such vacancy from the eligible list so certified to him, beginning with the name first appearing upon said list as each vacancy shall occur, but if at any time the said eligible list has been exhausted, or no one upon said eligible list appears to fill such vacancy in accordance with the provisions of this ordinance, after said vacancy has been advertised for a period of five (5) days, then in that event the Chief of the Fire Department shall notify the Commission and the Commission shall at once hold an examination, after giving five (5) days' notice thereof as hereinbefore provided; and the said Commission may from time to time hold such examinations as it sees proper in anticipation of any vacancies that may occur in said Department, so that there will be at all times an eligible list in the hands of the Chief of the Fire Department.

Sec. 13. The rules and regulations for the government of the Fire Department of the City of Tampa, approved by an ordinance and adopted on the 10th day of May, A. D. 1895, shall continue in full force and effect save and except when any of the provisions of said rules and regulations conflict with the provisions of this ordinance, and the officers of said Department, as provided for by said rules and regulations, shall be appointed upon a basis of merit, and by the Chief of the Fire Department upon the recommendation of the said Commission.

Sec. 14. Any officer or employee in the said Department intending to resign his position shall give at least thirty days' notice thereof before his resignation shall go into effect, unless by special permission obtained

from the Committee of the City Council on Water Works, Fire Protection and Electricity, he is permitted to do otherwise, and before any applicant shall become an employee or officer of the said Department he shall appear before the City Clerk and subscribe to the oath prescribed by section 12 of the City Charter.

Section 15. No employee in the Fire Department shall be required to perform any service except such as are required by the ordinances of the City of Tampa and the rules and regulations governing said Fire Department, and such other services as the very nature of his employment demands, and no employee in the said Department shall be suspended or discharged save for good cause, in accordance with the provisions of Section 43 of the Codification of the Ordinances of the City of Tampa, adopted by Ordinance No. 277, and if any employee in the Fire Department have an official grievance against the Chief of the Fire Department he shall have the right to make the same known by complaint to the Mayor of the City of Tampa, and any discrimination against said employee by the Chief of the Fire Department on account thereof shall be sufficient cause for the removal of the said Chief of the Fire Department under the provision of the City Charter, and if any employee have an official grievance against any other officer of the said Department he shall have the right to make complaint to the Committee on Water Works, Fire Protection and Electricity, who shall investigate the same and do justice in the matter and the said Committee shall have power, if the grievance is sufficiently serious, to direct the Chief of the Fire Department to prefer charges against said officer.

Sec. 16. In the event at any time or for any reason there should be a reduction as to the number of the employees in the said Fire Department, the Chief of the Fire Department shall report to the Commission the names of all the employees in said Department, and the Commission shall make an investigation as to the efficiency of said employees, and the least efficient shall be selected as the ones to retire from said service, taking into consideration the length of service in the Department along with the other qualifications, but such employees so laid off shall have the preference when filling any vacancy that may occur according to their respective merits.

Sec. 17. No employee shall be required or permitted to take part in the management of political organizations, caucuses, conventions or election campaigns, but the right of such employee to vote and express his views on public questions, either orally or through the press, is not denied, provided it does not interfere with the discharge of his official duties.

Sec. 18. The officers and employees in said Department be and the same are hereby prohibited from organizing said Department or any of its members into any union, society or organization in affiliation with any union or unions, organization or organizations, society or societies, and membership in any such union, organization or society, affiliated as aforesaid, shall render any applicant ineligible for appointment or employment in said Department, and shall be just cause for dismissal or discharge from service in said Department.

Sec. 19. From and after the passage of this ordinance and until the reorganization of the Fire Department under the provisions hereof, the Committee of the City Council upon Water Works, Fire Protection and Electricity shall possess the same powers and perform the same duties as are imposed upon and required of them by section 42 of the Codification of the Ordinances of the City of Tampa, but after the reorganization of said Department under the provisions of this ordinance said section 42 of the Codification of the Ordinances of the City of Tampa be and the same is hereby repealed in so far as the same conflicts with any of the provisions of this ordinance or the rules and regulations for the government of the said Fire Department herein adopted.

Sec. 20. All ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.

RULES AND REGULATIONS

OF THE

TAMPA FIRE DEPARTMENT (PAID FORCE.)

Employees of this Department shall give their entire time to the service and shall be at their headquarters at all times, except when in the performance of other duties, granted leave of absence, at meals, or when allowed elsewhere in these regulations to be absent.

DUTIES OF THE CHIEF.

Section 1. The equipment, disposition, control and management of the Department shall be entrusted to the Chief under the regulations and ordinances as may be made from time to time by the City Council of the City of Tampa.

Sec. 2. As the Chief is held responsible for the general performance of the duties of the men of the Department, he must give precise instructions as to the duties required of them. He shall superintend and direct all repairs to machinery, running gear, apparatus or other appliances or property of the Department. Upon completion of such repairs on work he shall inspect the work and pass upon the same before it is paid for by the City; he will cause all work and repairs to be done as far as possible by the employes of the Department.

Sec. 3. The Chief shall have power to suspend or fine any employee for neglect of duty or infractions of these or other rules, regulations or orders that may hereafter be issued.

Sec. 4. It shall be his duty to visit and inspect the different stations at least twice a week.

Sec. 5. He shall frequently visit the quarters and make a thorough inspection and will be held responsible for the keeping of said quarters in a proper condition of cleanliness.

Sec. 6. The Chief will see that employes of the Department perform strictly the duties of firemen which is primarily to extinguish conflagrations and not to save furniture or other personal property during fires.

Sec. 7. Upon an alarm of fire it will be the duty of the Chief to take control of the Fire Department, which department shall be under his absolute control for the extinguishment of fire and the preservation of property. He is authorized to apply to the chief of police to have the streets cleared of all persons not connected with the Department.

Sec. 8. He may, from time to time, issue such orders for the government of the Department as he may deem necessary, not conflicting with the Ordinances of the City.

DUTIES OF CAPTAINS.

Section 1. The Captains shall have charge of and be responsible for the condition, discipline and good order of their stations, the harness, equipments and other property in their charge.

Sec. 2. They shall be just, dignified and firm in their intercourse with the men, see that all rules, regulations and orders are properly carried out

and obeyed. They will promptly report any transgressions of ordinances, rules or orders that may have been or hereafter may be issued.

Sec. 3. They shall ride on the first piece of apparatus responding to an alarm of fire and direct the driver.

Sec. 4. They shall keep a correct account of all property entrusted to their care, together with such accounts or records that may be required of them by the City Council or their superior officers.

Sec. 5. They will see that all men as well as officers ride on the apparatus in going to and returning from an alarm of fire, unless it is impracticable by reason of heavy grades, rough pavements or other causes.

Sec. 6. They shall promptly report their arrival to the officer in command at the fire.

Sec. 7. Assume command at fires when they are first to arrive, and exercise command until the arrival of a superior officer.

Sec. 9. They shall call the roll and read to the company, except when otherwise directed, all general or special orders received since the last roll call, carefully, distinctly and slowly announce details for house water duty, give instructions for the day and properly admonish in all cases of irregularity or dereliction; make a personal inspection of each officer and member as to his personal appearance, uniform and equipments and all public property entrusted to his care.

Sec. 10. Make out and forward the morning report, reports of operations at fires and all other necessary papers to the Headquarters of the Chief of the Fire Department at nine a. m.

Sec. 11. Cause short excuses to be entered in the company journal. Preserve order and strict discipline in and about the station and at fires.

Sec. 12. Politely escort visitors and make proper explanation to them but not allow habitual lounging or visiting in or about the quarters; will prohibit all children under any and all circumstances from entering any building, yard or ground used for department purposes, unless accompanied by parents, guardians or attendants.

Sec. 13. Not permit visitors to handle any of the apparatus in the station. Not to permit members of the department to speak disrespectfully of their superior officers or of any member of the city government. Not to permit card playing or other games in quarters after midnight or on Sundays and do not allow gambling in the quarters at any time.

Sec. 14. They shall see that proper care is taken of all department stock located in their several stations and will be held responsible for the condition in which they are kept, and they will, in case of sickness to any of the stock, at once notify headquarters, or if any of the stock is hurt they will do likewise so that the veterinary can attend to them at once. Any failure to do the same will be punished by fine or dismissal, as the Fire Committee of the City Council may deem best for the welfare of the Department.

Sec. 15. They will cause all horses to be taught and practiced quickly take their places to the pole of the apparatus on the sound side of the gong by being exercised, and to see that the drivers and others do their full duty to the horses under any and all circumstances. They shall examine all feed that may be delivered to their stations and see that it is correct as to quality and quantity, and if found not correct they will at once report it to headquarters.

Sec. 16. They shall see that the apparatus is cleaned after each and every time that it leaves the station, and that each and every member keeps his bedding clean.

Sec. 17. They will perform such other duties as may be imposed upon them from time to time that the City Council or the Chief of the Fire Department may direct.

Sec. 18. It shall be the duty of the officer that is left in charge of the station during the absence of the Captain to assume all of the above responsibilities.

Sec. 19. Captains and officers in charge of stations will issue and

are out the feed used up in their stations, and the drivers and assistant drivers will see to the feeding of the stock, meal hours will be arranged so as not to conflict with this regulation.

Sec. 20. Captains and officers in charge of stations will see that the men vacate their beds by six a. m., unless permission is given to occupy them later than that hour, and the officer in charge of the stations will see that the morning meal hours begin at 6:15 a. m. promptly.

DUTIES OF SUPERINTENDENT FIRE ALARM SYSTEM

Section 1. It shall be the duty of the Superintendent of the Fire Alarm System to keep in efficient working order the fire alarm of the city; make all necessary repairs to same and at all times when leaving the station to register where he can be found. He shall report promptly at every alarm of fire to the chief or officer in command at same and to perform such other duties that may be imposed upon him by the City Council or the Chief of the Fire Department and he shall at all times have his battery and battery-room in a cleanly condition.

DUTIES OF CAPTAINS OF HOOK AND LADDERS.

Section 1. Captains of Hook and Ladder companies will ride as near as possible to their drivers so as to direct their movements and will not permit their apparatus to the location of a fire nearer than 100 feet, nor allow the same to be stopped in front of a fire hydrant.

Sec. 2. Officers of Hook and Ladder Companies shall have exclusive control and direction in the raising and placing of all ladders under the supervision of the officer in command at fires. He shall see that the premises in which fires occur are left in such condition that they will not cause further damage to life or property.

Sec. 3. Captains of the several stations of the Fire Department will see that the national standard is displayed on the company quarters from sunrise to sunset at the peak on the following days, to-wit: February 22d, July 4th and December 25th, and on such other holidays as may be designated by the President of the United States or the Governor of the State or Florida or on occasion of parade or inspection of the Department. On formal visits of the Governor of the State of Florida, Mayor of the City of Tampa, fire committee or any inspecting officer and when officially directed to do so by the Fire Committee or the Chief of the Fire Department.

Sec. 4. At half-mast on the receipt of official notice of the death of an officer holding a distinguished position in the nation, state or city government, a member of the Department who may have lost his life in the discharge of duty at a fire until sunset on the day of the funeral. Upon the death of any member of the Fire Department from natural causes the company to which he was attached will display its flag at half-mast until sunset of the day of the funeral. The national standard will not be displayed at any other time nor will it ever be loaned.

Sec. 5. Captains, in making out reports of operations at fires, will fill out the blank forms furnished by the Department.

Sec. 6. Any occurrence in connection with or incident to fire duty will be embraced in the reports of operations at fires and all other reports will be subject of a special report.

Sec. 7. They shall make a special report if at any time while working at fires of any person or persons driving over the hose and if possible obtain the name or names of the person or persons doing same.

Sec. 8. After the apparatus is placed in service at fires he will always be near his pipe so as to direct the movement of the pipeman to give signals where to place streams and regulate the force of same and will remain with pipeman until relieved by the officer in command of fire.

Sec. 9. They will, in case of assault committed by members of the Department, immediately notify the Chief of the Department by a special report. No further action will be taken in the case until directed by proper authority.

Sec. 10. They will state explicitly in their monthly report the description of apparatus, the number of horses used on each and when a change has been made or property has been dropped therefrom, what disposition has been made of same.

Sec. 11. They will see that the members of the Department carefully protect from waste or abuse all public property, particularly horse feed and forage.

DESCRIPTION OF ENGINES.

1st. When built or placed in service and name of builder.

2nd. Cost, weight, size, style and kind of boiler.

3d. Size in inches of steam cylinder, stroke of pumps and number of horses to engine and if equipped with three-horse gear. A correct statement must be given.

DESCRIPTION OF WAGONS.

When built or placed in service; registered number.

Where built and name of builder, cost, weight, style and number of horses used on same.

DESCRIPTION OF HOOK AND LADDER.

When built or placed in service, registered number, cost, weight, size, style, size in feet of longest ladder, number of horses used on truck, and if equipped with three-horse gear, state same.

DUTIES OF DRIVERS AND TILLERMEN.

Section 1. It shall be the duty of drivers to feed, groom and exercise their horses at such hours and within such limits as the chief may direct, and must keep their harness and stables in proper condition at all times.

Sec. 2. They shall drive their horses at all times and will be held strictly responsible for all careless or negligent driving. In turning corners the speed of the horses must be reduced almost to a walk. Tillermen of hook and ladder trucks shall keep the truck ladders, hooks and other appliances connected therewith in good order so far as may be in their power, so as to be ready for use at all times.

Sec. 3. They shall be required to perform such duties at station and fires as the chief may from time to time direct.

Sec. 4. They shall see that their apparatus is at all times ready for use; they will promptly report to the officer in charge of the station any damage to the apparatus or stock in their charge.

Sec. 5. Drivers, after responding to an alarm of fire, must first hitch their horses at a safe distance from the fire, and then report to the officer in charge of the fire for further instructions.

DUTIES OF ENGINEERS OF STEAMERS.

Section 1. The engineer of steamer will be held responsible for the condition and proper running of the engine and shall furnish a good and sufficient stream of water when required; shall not cause or allow the destruction of tubes, coils, boiler or any part of the machinery by want of water in boiler, by freezing or any cause, and if any of the parts are out of order, or if anything is wanting he will be held responsible until the same is reported to the chief.

Sec. 2. While standing in quarters he will keep the woodwork of the apparatus clean and the metal work free from dust and in perfect order. In cleaning the metal work use pulverized burnt Vienna lime and oil on brass, silver and copper, emery cloth on iron and steel (when not nickled) on parts where there is friction, clean cotton waste.

Sec. 3. Carry enough fuel in the fuel box to supply the furnace for at least one-half hour's work. Always have a torch prepared for lighting the fire by tying a small piece of oily waste with three or four matches to the end of a piece of wood, placed near the furnace door.

Sec. 4. The water-level in tubular boiler must be on a line with the third gauge cock, in pending tube boiler on line with second gauge cock and in the double shell nest tube and coil boiler two inches above second gauge.

Sec. 5. The nest tubes of the boiler must always be clean, using whalebone or reed brushes or steam hose as may be necessary, always from bottom through the door. Keep the cups above the steam cylinders always supplied with tallow and the cylinder drain cocks always open in quarters.

Sec. 6. Set the safety valve to lift at a pressure of one hundred pounds per square inch. Once in three months remove the valve from its chamber and clean off any corrosion that may have accumulated on the same.

Sec. 7. The engine must be turned over each day and placed on a different center; paint to avoid rust of piston rods.

Sec. 8. Oil holes of bearings and working parts must be clear of all accumulation and stuffing boxes kept properly packed.

Sec. 9. If the engine has not been out of quarters for two weeks it will be connected to hydrant in front of quarters. Generate a steam pressure of thirty pounds by wood fire, then throw in coals, work the engine a time until satisfied that all parts are in good order. Once a year clean water leg of boiler, by removing the mud plug, using hydrant pressure with small hose.

Sec. 10. Once each week, while cleaning quarters, remove all wheels of the apparatus and grease the axles, first wiping off the old grease from axle arms and wheel boxes. New axles will be examined and, if necessary, greased after each run for the first three months of use.

Sec. 11. All suction, hydrant connections, feed hose, etc., to be in order for instant use and supplied with proper washers. Engine to be always supplied with proper tools and wrenches.

Sec. 12. Upon receiving an alarm of fire to which company responds, will light the torch and when the engine reaches the sidewalk, ignite the fuel in the furnace.

Sec. 13. Upon reaching a hydrant in the vicinity of a fire, see that the suction is connected to the hydrant first and then to the engine, and be sure that the connections are air-tight and the engineer under no circumstances will engage in conversation while the engine is running.

Sec. 14. The relief valve in main pump will be set to lift at a pressure of a hundred and sixty pounds per square inch, but in case this pressure is not sufficient for the work to be performed, such as forcing water through a long line of hose or when the full power of the engine is required, the pressure will be increased by order of the officer in command of fire, the relief valve will be cut out, the pipeman will be notified of the fact and if a shut-off nozzle is on the pipe it will not be shut off until the order has been sent and the pressure reduced on the line.

Sec. 15. When the apparatus is placed at river to draft salt water, the suction joints and all connections must be perfectly tight, feed valve branching from the main pump closed and the churn valve set, before starting the engine.

Sec. 16. Upon returning to quarters after working salt water, the engine will be connected to hydrant and boiler and main pump thoroughly washed out.

Sec. 17. Oil steam cylinders once a month while standing in the engine house through the oil cup on top of cylinder.

GENERAL REGULATIONS.

Section 1. The sounding of the fire alarm at any time shall be a signal for all men connected with the Fire Department to immediately resume their duties and after sounding such an alarm, no man shall absent himself without permission from the Chief.

Sec. 2. No person shall ever be appointed to membership in the Fire Department who is not a citizen of the United States or who has ever been convicted of crime or who cannot read or write or be understood in the English language, or who shall not have resided in the state 6 months or in the county three months and one month in the city.

Sec. 3. No member shall absent himself from duty except by permission of the Chief or on account of sickness. Sickness resulting from the indiscretion of members will not be considered or accepted as excuse for absence from duty.

Sec. 4. Order and decorum must be preserved in going to and coming from fires; no racing will be allowed. All apparatus will, as far as practicable, keep on the open side of the street and in returning from fires or alarms the horses must not be driven faster than a walk. To guard against collisions or accidents when proceeding to fires or alarms, the gong will constantly be in use while the apparatus is in motion.

Sec. 5. When apparatus are placed in service the drivers and the firemen will be regarded as part of the working force and may be used by the officers at fires as in their judgment the circumstances of the service required when apparatus have been placed in service and the horses have been attended to they will promptly report to their captain for orders.

Sec. 6. Any driver of engine or any other heavy vehicle belonging to the Fire Department driving over the hose unless unavoidable will be subject to a fine or dismissal or reprimand at the discretion of the Fire Committee of the City Council.

Sec. 7. Members of the Department are strictly required in their intercourse with each other, social or official, to observe courteous demeanors and officers and men addressing each other will do so in a respectful manner.

Sec. 8. Profane or ungentlemanly language or disorderly conduct will not be allowed on the part of any officer or member while on duty under penalty of suspension or expulsion. No member shall be granted leave of absence without the permission of the Chief, and when considered necessary by the Chief the member granted leave of absence shall procure a substitute to his acceptance and the substitute must be on duty before the applicant leaves his post and the pay of the substitute shall be deducted from the pay of the principal. The meal hours will, from time to time, be designated by the Chief.

Sec. 9. All members of the Department and substitutes shall be provided with a badge to be known as the regulation badge of the Department, which shall be worn while on duty and no member of the Department or substitute shall lend his badge to any person on any pretext whatever. Any member or substitute who loses his badge will promptly report such loss to the officer in charge of his station and it shall be his duty to use all diligence to recover same. Any member who shall loan his badge to any person not connected with the Department will be subject to a fine or dismissal from the service.

Sec. 10. All member must address officers by their respective titles.

Sec. 11. Members are required to vacate their beds by 6 o'clock a. m. Members shall not leave their respective quarters without notifying the officer in charge of the station and upon their return from meals and all absence they shall likewise report.

Sec. 12. The officer in charge of the station may appoint the person who shall remain in charge during their temporary absence and will, upon return, report to him.

Sec. 13. Employees of the Department must wear the uniform adopted, except when absent from duty, cleaning up or after bed time at night. The work about the house must be completed by ten a. m., except at such times as may be necessary to clean up after an alarm of fire. At ten a. m. all members must appear in the following uniform to stand inspection: blue pants, blue shirt, and blue cap, the same uniform will be worn on the streets, excepting a blue coat must be worn at the inspection at ten a. m. The Captain will see that each and every man has on the proper uniform, together with all other City property intrusted to his care, such as badges, fire key and rule book.

Sec. 14. The officers of the station shall personally attend to the receiving of visitors. Visitors shall be courteously treated, have reasonable questions answered and any proper information given.

Sec. 15. Gambling will not be permitted at any time in or about any of the fire stations of the Department. Obscene, offensive, profane or indecent language will not be permitted.

Sec. 16. No employe of the Fire Department shall attend any political caucus or campaign, but nothing herein contained shall be taken to abridge the right of suffrage.

Sec. 17. No member will be allowed to enter any saloon for the purpose of drinking while on duty. No member shall be allowed to frequent a saloon or drinking place of any kind. If any member shall enter any house of the Department intoxicated or become intoxicated at a fire or while on duty, he shall be subject to fine or dismissal. Members are prohibited from having in their possession in the stations or allowing to be brought into or used in the station any spirituous or other intoxicating liquors.

Sec. 18. The occupant of each bed will be held responsible for the condition of their bed, and no member will occupy their bed from 6 a. m. to 8 p. m., except by permission of the officer in charge of the station.

Sec. 19. Upon receiving an alarm of fire, every officer and member will immediately report for fire duty on the apparatus floor, the horses will be hitched up and the Company prepared to leave quarters on the command to go to be given by the commanding officer at the instant he is assured the company is ready to perform fire duty at the location indicated.

Sec. 20. After the horses are hitched and the drivers and tillerman securely seated, they will report "Ready" in a loud tone, when the commanding officer will command "go," this will be the signal for the doors to be opened.

Sec. 21. Not loan or give away any of the property of the Fire Department, not sell or assign his salary or incur or contract any debts or liabilities which he is unable or unwilling to pay, or neglect or refuse to honorably discharge and promptly pay all indebtedness, claims and judgments, and satisfy all debts that are now held against him, and if the same is not settled within a reasonable time the member or members will be liable to suspension from the force.

Sec. 22. All officers and members of the Fire Department will be held responsible for all property belonging to the City entrusted to their care, and the following penalties will be enforced:

Sec. 23. Endeavor to detect and obtain evidence to convict parties from sending in false alarm for fire.

Sec. 24. Any officer or member of the Fire Department guilty of transgressing any law, ordinance, rule, resolution, regulation, circular orders, general, special or verbal, may be reprimanded, fined, suspended from duty

or be dismissed from the service of the Department, as the Fire Committee may determine, and any person so dismissed shall never be allowed to become a member of the Department again.

Sec. 25. The man or men on day watch will stay inside of the station, listen for the telephone, see after the horses and keep the floor in a clean condition, and not lounge around on the outside of the station.

Sec. 26. The telephones in the stations must only be used on business connected with the Fire Department, to call a doctor, or for a member to talk to his family for a few moments at a time. And at no time will a lengthy conversation be allowed.

Sec. 27. A man having a day off will not be expected as a substitute for a man wishing to get off on a leave of absence, as a man with a day off is subject to fire duty and therefore cannot fill a substitute's place, nor can a member having a day off leave the city without the permission of the Chief of the Fire Department.
