#### **VI. STAFF REPORT**

Portfolio Performance Review

ACG provided an update on capital markets and the monthly performance report for the period ending 9/30/20.

As of September 30, 2020, the total fund value stood at approximately \$728 million. Fiscal Year-to-Date as of September 30, 2020, the fund was up 8.13% gross of fees comparing to the Policy Index returns of 7.57% for the same period. Over the ten-year period ending September 30, 2020, the fund was up 8.19% gross of fees annualized, outperforming the policy index returns of 7.91% for the same period.

Board Counsel, Jorge Martin, presented a resolution for the Board to approve relating to the actions taken by Trustee Andy Waitman at the September 15, 2020 GE Pension Board of Trustees meeting. The Resolution provided for the ratification of those actions.
