- Remove pent rafter overhang on the gable ends, the north & south side;
- Wall section details to include the window setback, hardy board, and the minimum overhang of 2 ft. from the finished siding to the ends of the rafter tails;
- Floor plan and site plan are coordinated;
- Show documentation on block averaging on setbacks of the building; dimension taken from porch;
- Finished floor height, show documentation on how you arrived at stated floor height;
- Clarification of gutters, that they will be half rounds, provide spec sheet;
- Final location of AC unit;
- Site plan, showing placement of concrete driveway leading to double doors;
- Incorporate a roof cover or awning for both single and double doorways;
- Consider a gable vent to back gable; reduce number of vents on front gable;
- Clarification on stem wall materials to ground level.
