SUBCOMMITTEE	<i>Each subcommittee is tasked to review or provide recommendations on the following or as assigned by the CAC: (Note: subcommittees are not limited to the following, these items are purely examples)</i>
SPECIAL EVENTS AND PROJECTS	<i>Special Events Co-Sponsorship and Neighborhood Groups Special Projects Grant applications. Promotion and marketing of CRA activities. Special events and special projects and partnerships.</i>
ECONOMIC DEVELOPMENT	<i>Business development, business grant programs, economic development programs and initiatives. Identifying economic development partnerships. Development agreements. Improvement of the economic situation of residents. Local small business support strategies. Area development forums. Main Street support.</i>
INFRASTRUCTURE AND SAFETY	<i>Transportation and mobility, parking, streetscapes, sidewalks, lighting, signage, land use & zoning regulations, connectivity projects, urban design. Community policing initiatives in partnership with Police and Code Enforcement. Review of capital improvement projects affecting CRA. General Infrastructure.</i>
HOUSING	<i>Residential rehabilitation programs and grants. Affordable housing, infill housing, and bank/finance programs and partnerships relating to housing. Property acquisition for affordable housing. Community partnerships. Improvement of existing housing stock within WTCRA. Homeowner assistance.</i>
ARTS	<i>Public art projects, initiatives, awareness, and partnerships. CRA aesthetics and beautification through the arts.</i>

- Subcommittees focus on a particular task, project, or area within the WTCRA as assigned by the CAC.
- Subcommittee discussions and decisions are to be inline with the Florida Community Redevelopment Act and the West Tampa CRP.
- Subcommittee decisions are not CAC decisions. Subcommittees are purely advisory and provide recommendations.
- Each subcommittee is to be Chaired by a CAC member and composed of no more than 9 members.
- Subcommittee meetings are subject to Florida Sunshine Law, are publicly noticed with minutes taken, and meetings are run using Roberts Rules of Order.
- Subject matter may overlap between subcommittees and as such subcommittees may have joint meetings for overlapping subject matter, e.g., parks deal with infrastructure and public art.
