
Ms. Weber opened by recalling the recent City Council meeting in which the length of the Fund's disability process drew complaints. She provided background on the disability process and office procedures and offered a few suggestions that she thought could help shorten the process, albeit marginally. Mr. Klausner gave his opinion on the current policies and also offered some suggestions to possibly shorten the process.

The committee members discussed the policies, costs of the disability process, pension office staffing, and took the suggestions made by Ms. Weber and Mr. Klausner under advisement. **It was agreed to by general consensus to amend Policy 402 as recommended by Board Counsel and the Plan Administrator.** Ms. Weber also noted that the addition of an employee to the Pension Office staff whose main responsibility would be disability applications was a possibility.
