Happy Labor Day readers. Did you know that Labor Day became an official federal holiday in 1894? The first Labor Day celebration took place in 1882 in New York City. Today it is known mostly for a day off for professional and government workers, as well as backyard BBQs. The City recently passed several text amendments to the City code, including modifying the parking requirements for commercial vehicles, allowing for Street Café's (an outgrowth of Mayor Castor's Lift Up Local), home based businesses, food trucks and parking requirements for storefront residential uses. As you know, modifying the code is a labor intensive process and Development Coordination and City Planning staff are working diligently to amend Chapter 27 to make Tampa a better place to live, work and play.

The Office of Emergency Management is offering CERT training, which trains citizens to be prepared for and respond to emergencies that may arise in their community. 
### TREE INFORMATION
