

**ELECTION OF RIGHTS**  
**RE: TAMPA POLICE DEPARTMENT DERELICT VESSEL DETERMINATION**

I have read the Explanation of Rights provided to me by the Tampa Police Department (TPD) and understand my options. (You may select one of the options below and return this form to the TPD no later than 21 days from the notice of agency action or proposed action or, if you do not want an administrative hearing or informal proceeding, you do not need to complete this form).

1. I am challenging the agency action and want an informal proceeding. 2. I am challenging the agency action and want an administrative hearing. I do dispute one or more issues of material fact in the notice of agency action or proposed action, I have attached the completed and signed Petition for Administrative Proceeding form completed in accordance with Chapter 28-106, Florida Administrative code, or a petition that complies with Chapter 28-106, of the Florida Administrative code, and I request a formal hearing, pursuant to Sections 120.569 and 120.57(1), Florida Statutes, before an administrative law judge appointed by the Division of Administrative Hearings.

3. I do not wish to challenge the agency action. I do not dispute any of the issues of material fact in the Notice of action or proposed action and waive my right to object or to be heard.

I have read and understand the Election of Rights form and understand that I have the right to be represented by counsel or a qualified representative at an administrative proceeding. I also understand that I must attach a petition to this request if I have requested a hearing or an informal proceeding.
