- Legislative Update Mr. Kiner explained the new funding limitations in HB13/SB1770 and effect on current priorities for Drew Park.

CAC will send a letter through Mr. Kiner opposing both proposed bills.

- **DP CRA residential Properties** Mr. Kiner reviewed the locations of properties previously purchased by the CRA for building affordable housing in Drew Park. Due to the recession, those plans had been on hold. Mr. Kiner will start to look at reviewing the options for developing these properties.
- Drew Park Quarterly Newsletter The City has received proposals to provide quarterly newsletters to the CRAs. Cost is approximately \$2900 per newsletter for Drew Park.

• **Tampa Bay Boulevard** – Tentative schedule for project. Currently they are doing the survey and base maps for the areas. Once they have 30% plans complete, the first community meeting will be scheduled.

Community and meeting notice will be made.

• **Community Markers** – Received 2 responsive bids. Prices were estimated at about \$42,000 and lowest bid was \$80,000.

Discussion regarding rebidding or moving forward with bid received.

Mr. Forister moved to accept the lowest bid. Ms. Kulig seconded the motion and it passed unanimously.

- Legislative Update Mr. Kiner informed the CAC that HB13 was approved with an amendment to allow existing funding practices. Still no companion bill in Senate, but the Senate could take up the House Bill on the floor. Session closes on Friday.
- **Historical Marker** Installation of the pole is being scheduled. Once we know the pole is in, we can schedule a dedication ceremony and the marker itself will be installed just prior to the ceremony.
- Drew Park Quarterly Newsletter The CRAs approved a contract with Chameleon for six months and Drew Park will be working with them on two newsletters. Topics are being developed.

V. Project Update Reports by Mr. Kiner -

• **FY18 Draft Budget** – Projected revenue continues to trend upward as updated figures are received. The projected \$744,000 has increased to \$913,000. Mr. Kiner reviewed some of the projects identified in the Landscape Master Plan with Tampa Bay Boulevard linear park being the next large expense.

Mr. Forister made a motion to approve the updated FY18 Budget. Mr. Beal seconded the motion and it passed unanimously.

- **Tampa Bay Boulevard** The engineer is submitting 30% documents on Monday with a first estimate of potential costs. Next step will be to bring the two design options identified to the community for input. The first community meeting will be July 20, 2018 at HCC.
- Bus Shelters Installation of the bus shelters is imminent. HART is changing bus route for #7 starting in October and that reduced the number of shelters installed.
- ICCC Program Regions Bank is going out to community groups to talk about their program to assist existing small businesses ready to take it to the next level. The program is free and provides and incredible opportunity to talk with and learn from leaders in business. Information packets distributed.
- **Historical Marker** The pole has been installed and the marker will be installed right before the dedication ceremony.
- Community Markers Mr. Kiner reviewed the bid results and the proposed cost of \$80,000. Mr. Poole expressed concern that because the approval process took so long the result was a higher price to the TIF. Options are to accept the bid or reject the bid and go back out and rebid the project.

Mr. Poole made a motion to accept the bid for construction and installation. Mr. Forister seconded the motion and it passed unanimously.

III. Project Update Reports by Mr. Kiner

- **Historical Marker** Dedication of the Drew Field historical marker is November 1 at 8:30 am.
- **CRA Residential Properties** Mr. Kiner is waiting for the current appraisals to be completed. \$647,800 was spent to acquire all the parcels for affordable, workforce housing in 2009. The properties are zoned RM16 multi-family.
 - Mr. Kiner will review the Strategic Action Plan regarding housing.
 - The next step would be to go out with an RFP.
- **City-owned property** The property at Crest and Lois had been offered through a RFP and the deal fell through. RFP will be re-issued.
- **Community Markers** Markers are being fabricated and will hopefully be installed in early December. The footers for the markers needed to be adjusted due to soils issues.

- Façade Grants Ms. Van Loan reviewed the three projects recently approved:
 - 3901 W. Osborne. Replacement of front door with side panel windows. Grant \$1,675.
 - o 5005 N. Clark. Building and site improvements. Grant \$31,320.
 - o 5005 N. Hesperides. Phase II site improvements. Grant \$50,000.
- FRA Conference Mr. Kiner provided information on the upcoming FRA Conference.

IV. Discussion / Questions

Tampa Bay Boulevard Linear Park:

At the last meeting, regarding the discussion of Design Option A & B, Mr. Cowan supported option B because he thought that design would provide open space for more uses for his employees located across the street.

After discussion with his employees and further reflection on how the greater community might use the park and the aesthetics of both options, Mr. Cowan would like to re-discuss the design options. Mr. Cowan now prefers the more aesthetically pleasing and environmentally responsible Option A.

Discussion:

- Option B provides for a more open design, and flexibility of use over time.
- Option A would cost more to maintain.
- Concern Option A would end up looking like a planted ditch, and not look very pleasing without a lot of maintenance.
- Concern Option A will attract dumping and unwanted activity.

CAC maintains its preference for Option B.

There will be a community meeting in early December on the Linear Park.

V. General Discussion

- Some of the decorative lights are out on Lois.
