An application will not be scheduled before the Historic Preservation Commission (HPC) until all fees have been paid and exhibit requirements in accordance with the City of Tampa Code of Ordinances have been satisfied. Additionally, all cases must be noticed in accordance with Section 27-149(c) before they can be heard by the HPC.
