I. PLEDGE OF ALLEGIANCE

Chairman Hill led the pledge of allegiance.

II. ROLL CALL

Mr. Hill, Chairman, presiding, brought the meeting to order at 1:30 p.m.

III. PUBLIC COMMENTS - Ten (10) Minutes Total - Three (3) Minutes per Speaker

IV. APPROVAL OF MINUTES

Mr. Hill requested the Board approve the meeting minutes from September 12, 2023.

Discussion ensued regarding a portion of the minutes relating to Asset Consulting Group's contract renewal. The contract term is three years with automatic annual renewal.

V. DISABILITY RETIREMENT HEARING

The hearing began with reports presented from Independent Medical Examiners (IME) to the Board relating to the Disability Retirement claim on Leonides Perez Jr. Discussion ensued relating to the IME reports.



MOTION: Steve Kenny made motion to approve Disability Retirement for Leonides Perez Jr. Jonette Socall seconded the motion. MOTION CARRIED.

VI. INVESTMENT CONSULTANT REPORT

The City of Tampa's fixed income managers presented firm, portfolio, and performance updates on their strategies to the Board. JP Morgan was represented by Alex Harlan, Sherri Tilley and Amy McPike represented Manulife, and Adam Phillips represented Loop Capital.

ACG provided an update on capital markets and the monthly performance report for the period ending 9/30/23.

As of September 30, 2023, the total fund value stood at approximately \$746 million. Fiscal year-to-date through September 30, 2023, the fund has returned 11.78% gross of fees, outperforming the Policy Index returns of 10.97% for the same period. Over the five-year period ending September 30, 2023, the Fund is up 5.39% gross of fees annualized compared to the policy index of 4.96% for the same period. On a tenyear basis, the portfolio is up 6.57% gross of fees versus 6.18% for the Policy Index.

VII. LEGAL REPORT

Justin Vaske reported that the Side Letter for Redwheel has been completed and submitted for review by Redwheel's legal team.

| Methodology |

Economic Overview

- 3rd quarter US GDP grew at a robust 4.9% rate, the highest since 4Q 2021, with consumer spending accounting for over half of the growth
- Core CPI increased 0.3% on the month for a 4.1% year-over-year rise, in-line with expectations and down from last month's 4.3% rate
- 10-year US Treasury yields briefly touched 5%, the highest in 16 years, and higher interest rates continued to pressure asset prices










Total Portfolio


