SUBJECT: Ridgewood Park Neighborhood Resurfacing and Traffic Calming Workshop

The City of Tampa Transportation and Stormwater Services Department will conduct a public information meeting for the Ridgewood Park Neighborhood Resurfacing and Traffic Calming Project. The boundaries of this project are W Columbus Dr. on the north, N Boulevard on the east, and the Hillsborough River along the south and west. It will include the rehabilitation of existing roadway and drainage conditions and implementation of traffic calming measures for safety enhancement.

The presentation is followed by an interactive traffic calming workshop where residents can provide traffic calming recommendations and input to what is being designed and where it is being constructed.
