

**PUBLIC NOTICE
PUBLIC COMMENT PERIOD & PUBLIC HEARING
CITY OF TAMPA
PROGRAM YEAR 2023 ANNUAL ACTION PLAN**

NOTICE IS GIVEN that a draft of the Program Year (PY) 2023 Annual Action Plan (AAP) will be available for a thirty (30) day public comment and review period.

The City of Tampa is designated as an entitlement community by the U.S. Department of Housing and Urban Development (HUD), and as such is eligible to receive Community Development Block Grant (CDBG) Program, Home Investment Partnerships (HOME) Program, Emergency Solutions Grants (ESG) Program And Housing Opportunities For Persons With Aids (HOPWA) Program funds annually. To receive these funds, the City must develop and submit a Consolidated Plan every five years and an AAP for each year of the plan. The PY 2023 AAP projects and activities were developed to further accomplish the goals set in the City's 2022-2026 Consolidated Plan. The proposed activities in the plan are intended to benefit low- to moderate-income residents in Tampa. PY 2023 begins on October 1, 2023, and ends on September 30, 2024. The PY 2023 annual allocation of grant funds were \$3,192,769 for CDBG, \$1,919,269 for HOME, \$279,563 for ESG, and \$5,268,843 for HOPWA. The City also anticipates receiving program income of \$50,000 for CDBG and \$50,000 for HOME in the Down Payment Assistance program. The following use of funds were proposed:
