

Application and Award Process



Funding Available

The City of Tampa (City) is seeking proposals from qualified Organizations/Agencies to expand the capacity of shelter programs serving persons or families experiencing homelessness within the City of Tampa limits.

City of Tampa Housing Program Funds Up to \$500,000

*Multiple agencies can be awarded

CoT Homeless Outreach Team Partnership – With this funding opportunity, the city is aiming to partner and create a streamlined process for the City's Street Outreach Team to access shelter beds.

Eligible Expenses

The following expense shall be considered eligible for funding under the program:

- Reimbursement of Shelter Beds
 - \$60.00 per bed per night.

Service Guidelines and Expectations

- Shelter programs must have realistic and clear expectations. Rules and policies must be narrowly focused on maintaining a safe environment for residents and the community and avoiding exits to homelessness.
- Shelters must be oriented toward exiting people to permanent housing.
- Shelter programs must not require participants to pay a share of rent that they are being reimbursed for.
- Programs should have housing stability focused services and case management.
- Programs should have case management services focused on diversion, problem-solving, and when appropriate collaboration with the Coordinated Entry System.

Submission Process

- Applications must be submitted via Neighborly no later than 5:00PM (EST), March 12, 2024.

Role of Reviewers

City Staff will verify all required documentation is included in the application.

The **Reviewers** will evaluate the proposals submitted and assist the City by making funding recommendations.


*The City will use recommendations from the Reviewers to make award decisions

Allocating Points

<u>Points</u>	<u>Guidance</u>
Maximum points	More than adequate response
Medium points	Adequate response, no special insight
No points	Inadequate or no response

Equal Business Opportunity (EBO) Program

- Certification Eligibility is open to all <u>Independently Owned</u> and <u>Operated</u> small businesses including women and minority-owned companies
- **SLBE** = size, gross revenues, location (Hillsborough, Polk, Pinellas, Pasco, Manatee)
- WMBE = 51% ownership and control by the minority or female individual(s) regardless of trade specialty or profession (statewide)
