# **DEPARTMENT ANNOUNCEMENTS!**

Welcome to 2024! May this year be the best ever for you, your family and the City of Tampa. The start of the decade was a difficult one, but we made it through 2023. Development Coordination had a lot of transition, saying goodbye to Jayne Nmadu, Zain Husain and Annie Barnes, but welcoming David Hunter, Sam Thomas, Waldo Carbo, Miguel Aguila and Solleevon Johnson.

As a group, Development Coordination processed over 4,700 different types of applications, ranging from a simple certification letter to the review and approval of the GasWorx project.

The City will be awarding a consultant to assist with the amending and updating of Chapter 27. This will be a multiyear process. The selection committee includes representatives from Development Coordination, the Planning Commission, Purchasing, Minority Business Development, City Planning, the City Attorney's office and a member of the public. Once selected, the consultant will be meeting with both internal and external stakeholders.

At the November 30th City Council Workshop, representatives from USF and the City Planning Department presented the results of the **City of Tampa Tree Canopy and Urban Forest Analysis**. A video of the presentation and more information on the city's urban forest initiatives can be found on the City Planning Department website.

The City Planning Department coordinates biannual updates to the Land Development Code as set forth by Sec. 27-147. Below is the current list of active amendments and information to participate in the process. #### July 2023 Amendment Cycle

Tentative proposed amendments (subject to change):

- Amendment 23-11: Article 3, Division 2, Subdivision 3, "Central Business District"- Update the CBD street typologies map to reflect existing and imminent changes to the street grid. Amend Type B and C street details.
- Amendment 23-12: Sections 27-91, 27-211, 27-231, 27-271, 27-330- Clarify that historic district requirements take precedence over the general zoning code.
- Amendment 23-13: Section 27-150- Adds language specifying that a rezoning ordinance is deemed automatically withdrawn when a comprehensive plan amendment is not approved.
- Amendment 23-14: Section 27-21- Cleanup of footnote reference in the Consistency Matrix.
- Amendment 23-15: Section 19-58, 27-287.25- Enforcement of hazardous grand tree removals.
- Amendment 23-16: Section 283.11- Updates to commercial vehicle parking standards.
- Amendment 23-17: Section 27-149- Expand notice area; require a notice of filing for cases that require a public hearing.
- Amendment 23-18: Section 27-199, Table 19-2 Channel District—Increase maximum height in CD-1 zoning from 60' to 175' to be consistent with CD-2 zoning.



Tampa Connect is a Customer Relationship Management System that is a state-of-the-art technology solution designed for the support of the City of Tampa's response and management of our citizen service requests implemented November 15, 2023. Tampa Connect replaces the Customer Service Center (CSC) to create a more seamless customer experience. This solution offers efficient and centralized management of citizens communication

#### Here are a few important notes for you to be aware of during the transition to Tampa Connect:

Customer Service Center (CSC) will remain open internally until December 31, 2023 to respond and close existing requests. The CSC will no longer be available for citizens to add NEW requests as of November 15, 2023. Tampa Connect will be the ONLY portal for citizens to enter new service requests. Current department staff can continue to resolve CSC requests until December 31, 2023.

**Effective January 1, 2024, all remaining CSC requests will automatically be closed.** Citizens will receive an email notification that their respective request has been closed with instructions on how to open a new service request in Tampa Connect.

**Tampa Connect Agents:** Each department that utilizes Tampa Connect to receive and resolve citizen service re quests, has access to the Tampa Connect system. <u>Click here</u> to see licensed department agents.
