

RESOLUTION NO. 2024- 833

A RESOLUTION ADOPTING THE CITY OF TAMPA CAPITAL IMPROVEMENT BUDGET AND PROGRAM FOR FISCAL YEAR 2025 THROUGH FISCAL YEAR 2029; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Mayor, after review of the City of Tampa, Capital Improvement Budget and Program for Fiscal Year ("FY") 2025 through FY2029, submitted a recommended Capital Improvement Budget and Program to the City Council as part of the FY2025 Annual Budget; and

WHEREAS, upon receipt of said Budget by the City Council, a public hearing was called and held by the City Council as required by the Laws of the State of Florida, after due advertisement of notice thereof; and

WHEREAS, after careful study of said Capital Improvement Budget and Program, the City Council has determined that said Budget and Program, without amendment or revision, conforms to the requirements of law and is a due and proper Capital Improvement Budget and Program for the aforesaid period.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL

Section 2. That the proper officers of the City of Tampa are hereby authorized to do all things necessary and proper in order to carry out and make effective the terms and conditions of this Resolution which shall become effective immediately upon its adoption.

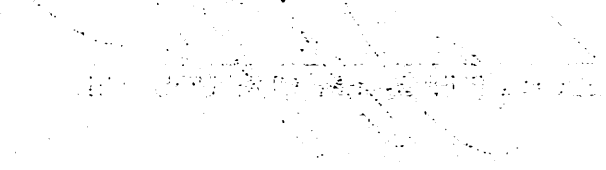
