

**MINUTES OF THE SPECIAL BOARD MEETING OF THE  
TAMPA FIRE & POLICE PENSION FUND**

The Board of Trustees of the City Pension Fund for Firefighters and Police Officers in the City of Tampa met on Monday, April 15, 2024 at 11:30 a.m. for the purpose of formal hearing continuance proceedings for line-of-duty disability applicant Travis Smith, formerly of TPD, with the following members present:

Also present were Dr. Bruce Bohnker, Medical Director; Dr. Mark Glencross, Medical Director; Mr. Pedro Herrera, Legal Advocate for Board; Mr. Robert Klausner, General Counsel; Mr. Paolo Longo, Counsel for Mr. Smith; and Mr. Travis Smith, Disability Applicant.

Mr. Messmer began by notifying Mr. Smith and Mr. Longo that one trustee was absent. Mr. Longo stated that the absence was noted and that they wished to proceed. Mr. Klausner advised the Board that the burden of proof was on the applicant. He further stated that the application, relevant personnel documents, and all medical evidence were admitted into the record. Mr. Longo made an opening statement, detailing timelines and the circumstances of Mr. Smith's ailments. Mr. Herrera followed with an opening statement of his own, opining that the case did not contain any objective findings. Discussion was held regarding the deposition of Dr. Harris, which was provided to the Board and later added to the record. Mr. Smith was then sworn in.

Following procedure, Mr. Longo stated that his case was based on the record presented to the Board and opined that the burden of proof had been met. Mr. Longo did not present the applicant as a witness. Mr. Herrera countered that various medical reports, exams, and depositions left the cause of Mr. Smith's afflictions in question. He cited conditions from Mr. Smith's pre-employment physical as possibly playing a role in his current condition.

Mr. Herrera called Mr. Smith as a witness and questioned him prior worker's comp claims, specific incidents where he felt his job was directly affected by his health problems, and his current well-being. Questions from the trustees were also directed to Mr. Smith. Mr. Longo declined to redirect.

Mr. Longo combined his rebuttal and closing statements. He argued that satisfactory evidence existed across all three prongs of the disability statute. Mr. Herrera then provided his closing, opining again that the burden of proof had not been carried and recommended denial of the disability to Mr. Smith.

Mr. Messmer requested that Mr. Klausner review legal aspects related to worker's comp and any applicable presumption for all parties. Mr. Klausner cited relevant case law. Following the remarks, **it was moved by Mr. Belmonte, seconded by Mr. Stock to deny the line of duty disability application for T. Smith on the basis of causation, totality and permanence.**

Discussion followed the motion with Mr. Messmer questioning if totality had been met. Mr. Klausner opined that it was with Mr. Smith's termination from the City of Tampa he should be considered totally disabled on the basis of existing case law. Mr. Klausner further stated permanency and causation still had






to be proven. **Mr. Belmonte amended his motion to deny the line of duty disability application for T. Smith based on causation and permanency. Mr. Stock seconded with Mr. Haintz, Mr. Rogero, Mr. Spearman, and Ms. Wynn in favor of the motion and Mr. Cannon and Mr. Messmer opposed.**

Mr. Klausner noted that he would draft the final order.

The meeting was adjourned at 1:48 p.m.
