Committee #2 of the Board of Trustees of the City Pension Fund for Firefighters and Police Officers in the City of Tampa met on Monday, June 10, 2024 at 10:00 a.m. to discuss the annual review of Fund professionals, with the following members present:

Mr. Belmonte advised that the purpose of the meeting was to conduct the annual review of professional services provided to the board and formulate recommendations concerning retention or disengagement. A summary of the professionals was presented for review.

Mr. Belmonte noted his preference to discontinue reviewing every professional individually and instead only hold discussion on those the committee felt warranted deliberation. Discussion was held regarding Tampa General Hospital and the Medical Director position. Ms. Weber and Ms. Corry provided feedback from an administrative and operational standpoint. The committee discussed professional fees and the RFI process, after which *it was agreed to by consensus to retain all professionals with a meeting to be scheduled between the Plan Administrator, Chairman of the Board and TGH administration to address specific items concerning the Medical Director.* Ms. Corry stated she would facilitate the meeting.
