Committee #3 of the Board of Trustees of the City Pension Fund for Firefighters and Police Officers in the City of Tampa met on Tuesday, August 20, 2024, at 1:00 p.m. to discuss the Board's policies and procedures for disability reevaluations, definition of "in the service" pension coverage, benefit payments, and preemployment medical screening, with the following members present:

Ocea Wynn, Committee Chair John Haintz Alex Thiel

Ms. Weber began the meeting with discussion on policy 307. She explained the additional proposed language is to clarify that members or retirees hired by a secondary employer providing education and/or training services to either the fire or police department are not covered by the pension contract. *This recommendation was agreed to by consensus.* 

Policy 409 was discussed next. It was noted that this policy was discussed at the previous meeting and the draft policy is presented for review by the committee. Clarification was provided that the definition of "certain disability retirees" does not apply to the self-reporting process which applies to all disability retirees. *This recommendation was agreed to by consensus*.

Ms. Weber advised the policy 424 was referred to committee at the last board meeting following a member request for early access to his DROP funds. The distribution processed was reviewed and concerns were raised about making changes to the distribution process. It was agreed that the committee would not make any recommendations for change at this time.

There was brief discussion regarding policy 401. Ms. Weber advised that the proposed language is to clarify that a Doctor of Osteopathy (D.O.) can participate in both the admission and disability medical boards. It was noted that the Fund's policies already allow for this type of provider to participate in the process via the qualifying letter. *This recommendation was agreed to by consensus*.

Lastly, policy 605 was introduced for discussion pertaining to travel related expenses. The policy limitation of the continental United States was discussed, and it was agreed that there are reasonable education opportunities that are being excluded. It was decided to propose language changing this limitation to the United States and its territories. Prohibited expenses were also reviewed and proposed language clarifies that premium upgrades are non-covered expense. This recommendation was agreed to by consensus.

Motion to adjourn was made at 2:04 p.m.
