The Board of Trustees of the City Pension Fund for Firefighters and Police Officers in the City of Tampa met on Wednesday, December 18, 2024 at 9:30 a.m. for a regular meeting with the following members present:

1. Approved the minutes of the November 20, 2024 regular board meeting. **It was moved by Mr. Thiel, seconded by Mr. Cannon and by unanimous vote to approve the minutes of the November 20, 2024 regular board meeting.**

Mr. Messmer requested item #4 be removed for discussion. **It was moved by Mr. Belmonte, seconded by Mr. Thiel and by unanimous vote to approve consent agenda items 2 – 3 and 5-7.**

New Business

10. Noted receipt of listing of upcoming conferences. Disclosure of planned attendance, if any.
Ms. Weber tentatively disclosed for the January FPPTA Trustee School. Mr. Haintz confirmed his planned attendance for the same. Mr. Stock noted that he would not be attending the KORIED sponsored Educational Institute in Key West.
11. Approval of the 2024 Summary Plan Description (SPD).
Ms. Weber informed that there were only minor revisions made this year and reminded the board that the SPD was required every other year or when changes to the Plan are made. Mr. Messmer suggested to include the track changes in the board package whenever future SPDs came up for approval. Ms. Weber stated this was an oversight and would ensure a redline version would be in future board packages. **It was moved by Mr. Messmer, seconded by Mr. Belmonte and by unanimous vote to approve the 2024 Summary Plan Description.**
12. Investment committee report.
Mr. Messmer noted that there were no changes to the Investment Policy at this time. He stated that the committee did discuss modifications regarding securities litigation and that he would have a redline revision ready to present to the board at the January meeting.
13. Chair's call for any new business items from trustees to be placed on next agenda. None.
14. Chair's report. None.
15. Plan Administration: external audit, DROP, COLA, calendar year end, City Clerk request

Ms. Weber stated that the audit was still moving along and on track for the February agenda. She stated DROP distributions for the year had been approved and that COLAs would take effect next month, with 1099s also going out in January. She alerted the board that the City Clerk requested trustee information, including disability status, for a report they have to file with the state. Mr. Klausner opined that there was no mandatory requirement for the board members to respond, but that if they did feel like it to respond “per the advice of counsel, no information is being provided.” Following discussion, Ms. Weber stated that she would notify the Clerk’s office of Mr. Klausner’s opinion.

16. Attorney’s report.

Mr. Klausner reminded the board of the pending social security offset elimination. With a brief note on the Appel case, he stated that a judge’s signature was forthcoming to allow garnishments through Regions Bank.

Mr. Klausner stated that a garnishment order is pending and clarified the garnishment will be on his bank account, not his pension benefit.
