Committee #3 of the Board of Trustees of the City Pension Fund for Firefighters and Police Officers in the City of Tampa met on Friday, October 10, 2025 at 11:00 a.m. to discuss policies 806 and 817, with the following members present:

Ocea Wynn, Committee Chair Gabriel Hahn Alex Thiel

Ms. Weber gave background regarding the most recent trustee election and mailing issues with ballots. Discussion was held with regard to moving future elections largely to virtual ballots, with physical ballots available only upon request. It was agreed to by consensus to recommend to the board the dissolution of mail-in ballots for trustee elections, except upon request, with virtual voting through MemberDirect becoming the primary mechanism. Ms. Weber stated that she would make the redline changes to Policy 806 and communicate the potential change to membership multiple ways.

Concerning policy 817, Ms. Weber overviewed past examples of requests made from members or their attorneys directly to a Fund professional that could have been handled by the pension office. Discussion took place, with Mr. Klausner recommending added language to the policy to incorporate the Plan Administrator, and potentially the Chairman, to facilitate the most appropriate response for a given matter. *This was agreed to recommend to the board by consensus.* Ms. Weber stated that she would make the redline changes to Policy 817, with Mr. Klausner circulating the potential change to the Fund professionals.
