

## **Business Impact Estimate**

### **Section 166.041(4), Florida Statutes**

This Business Impact Statement concerns a proposed ordinance of the City of Tampa, Florida, the title of which is as follows:

#### ***Insert Proposed Ordinance Title:***

An Ordinance of the City of Tampa, Florida, amending City of Tampa Code Chapter 2, Article V, Division 3, purchases and contracts, by enacting section 2-287, purchases through use of other cooperative contracts; providing for repeal of all ordinances or parts of ordinances in conflict therewith; providing for severability; providing an effective date.
