ANNUAL REPORT

OF THE

Chief of the Tampa Fire Department,

From June 1, 1902 to May 31, 1903.

To The Hon. James McKay, Mayor, And To The President And Members Of The City Council—Gentlemen:

I herewith hand you the report of the workings of the Fire Department for the fiscal year ending May 31, 1903.

The present fiscal year has been a memorable one in the Fire Department, and this Department has been the cynosure of the whole country for a certain period.

On the 5th of the present year the Fire Committee instructed me to reduce the expenses of the Department, as the Department was over-running its appropriation. There were only one of two things to do: Reduce the salaries of the men, or reduce the force. Not wishing to cut salaries, as they are not what they ought to be for the work required, being very hazardous, and the confinement being attached to it great, I laid off three of the permanent force and one extra man. Prior to this the members had organized themselves into a Labor Union, and affiliated with the American Federation of Labor. On January the 9th a representative of the Central Trades Assembly appeared before your honorable body as a representative of the Firemen's Labor Union and demanded the reinstatement of the four men laid off, threatening if same was not done, they would leave their posts of duty at once, which threat was carried into effect, leaving at 9:30 P. M., thereby leaving

the lives and property of the citizens at the mercy of the flames.

In my humble opinion, your honorable body's name will go down into history for the noble and fearless stand you took at that memorable meeting of January 9, 1903.

I, being very ill at the time, did not know what was going on in the Department, the physician having me under opiates, but on the next day I regained consciousness, and was ordered away from the city for a few days, leaving by order of the Fire Committee on January 12, and returning on the 14th of the same month.

On the 14th of January of the present year the Fire Committee caused to be inserted in the daily papers of the city an advertisement for able-bodied men to take the place of the striking firemen; the Chief, or in his absence the Assistant Chief, to be the judge of the men applying for positions in the Department. On the 15th I employed thirty men to take the places vacated by the striking firemen, and began at once to instruct them in their duties.

On February 21, 1903, your honorable body passed an ordinance, numbered 307, reorganizing the Department, placing same on a civil service basis, and I must say this has been a good thing for the city and the Department.

On February 11, some party or parties with incendiary notions, attempted to destroy this city by applying the torch. Eight incendiary fires were started in as many different portions of the city, the first at 1:15 A. M. and the eighth at 3:10 A. M.

Although the wind was blowing very hard at the time of the conflagration, and all the fires in frame structures filled with inflammable stocks, the new firemen, with the help of a great many of the citizens, kept the flames confined to where they started, as your honorable body well knows.

On March the 12, of the present year, the Fire Committee being named as the commissioners in ordinance No. 307, to examine the applicants for positions in the Department, held said meeting, and finished their labors on the 14th.

They certified to me all the members who were on duty at the time, with the exception of four who failed to pass the physical examination, and I have added to

the force a few more men, by order of said commission.

Today, the city has a better Department than she had prior to the strike of January the 9, 1903.

In conclusion I wish to thank the Mayor, and members of the Council, more especially my Fire Committee, for the assistance they rendered me during that memorable strike, to the Police Department for assistance, and to all citizens who came to the Department's assistance during the time of need.

CASUALTIES TO MEMBERS.

From June 1, 1902, to May 31, 1903.

October 2, 1902—Hoseman J. E. Holton; sprained left ankle running to catch car on meal hour; time lost, 12 hours.

October 15—Driver Chemical, W. L. Dunlap; hurt left knee playing football in front of station; time lost, 2 days.

April 8—Hoseman J. T. Corcoran; sprained ankle while practicing on scaling ladders; time lost, 5 days.

CASUALTIES TO STOCK AND APPARATUS.

From June 1, 1902, to May 31, 1903.

August 13—Broke shaft on single horse truck while responding to Box 41; caused by horse falling.

September 9—Horse Gibbons badly bruised by kicking in stall.

October 2, 1902—One of Chemical horses fell turning corner and sprained left fore ankle.

October 24—One of Chemical team sprained left hind leg while responding to an alarm of fire.

February 15, 1903—Chief's Day horse hurt on left shoulder and leg by falling in turning corner while on the way to a fire.

The Veterinary Surgeon paid forty visits during the year to the different Stations, to examine the stock of the Department.

Sir:

Attached you will find my report of the workings of both Fire and Police systems under my control, with the location of all the street boxes belonging to both systems, also the number of alarms sent in, and electric light inspections made by me, including supplies received and material used, and where used.

There have been but few changes made in the past year. The changes made, however, have been such as would better the working condition of the Department, with as small cost to the city as possible. The general outside construction is such that should our City be visited by any severe wind storm, it would leave us badly crippled, not to speak of thousands of dollars loss to the

City in machinery, etc., and also liable to leave us without any alarm service.

Therefore, I again recommend placing the City wires under ground, in duct furnished by the Peninsular Telephone Co., at least in the business district, and that poles be purchased for the reconstruction of outside lines.

I also recommend the purchase of four additional fire alarm boxes to cover the district so thickly settled, and with buildings going up every day, which places the Fire Department at a disadvantage in getting the alarm promptly.

With the above recommendations, which sooner or later must be done or the City placed at the mercy of the flames, this Department will be in first class condition.
