A RESOLUTION MAKING CERTAIN CHANGES IN THE BUDGET OF THE CITY OF TAMPA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2025; APPROVING THE TRANSFER, REALLOCATION, AND/OR APPROPRIATION OF \$4,468,840 FOR INTEREST AND OTHER INCOME EARNED THROUGH THE THIRD QUARTER OF FY2025 WITHIN THE CENTRAL PARK, CHANNEL DISTRICT, DOWNTOWN CORE, DOWNTOWN NON CORE, DREW PARK, WEST TAMPA, EAST TAMPA, TAMPA HEIGHTS RIVERFRONT, YBOR I, YBOR II AND MASTER INFRASTRUCTURE PROJECT (SPP) COMMUNITY REDEVELOPMENT AGENCY (CRA) FUNDS; PROVIDING AN EFFECTIVE DATE.

Section 1. The transfer, reallocation, and/or appropriation of the sum of \$4,468,840 within the Central Park, Channel District, Downtown Core, Downtown Non Core, Drew Park, West Tampa, East Tampa, Tampa Heights Riverfront, Ybor I, Ybor II and Master Infrastructure Project (SPP) CRA Funds, as set forth below, is hereby approved.
