Move to recommend City Council deny ARC-25-0000226/REZ 25-48 for the property located at 613 S. Magnolia Avenue, 601 & 611 W. Swann Avenue, 612 & 614 W. Bay Street, & 611 S. Magnolia Avenue, for the proposed rezoning from RO-1 to PD for the reasons stated by staff, it exceeds historical references in the historic district in height and width, plans present building widths that extend the entire length of the block, setbacks proposed within the historic fabric are inconsistent and larger than those on the adjacent sites.
