

Business Impact Estimate

Section 166.041(4), Florida Statutes

This Business Impact Statement concerns a proposed ordinance of the City of Tampa, Florida, the title of which is as follows:

Business Impact Estimate

The City provides the following Business Impact Estimate, which may be revised following its initial posting:

The proposed ordinance will remove a criterion for evaluating whether the construction of a sidewalk is impracticable as it relates to the City's sidewalk in-lieu fee.
