**Meeting Minutes**

The Tampa Police Department was represented by Chief of Police Lee Bercaw, Captain of Professional Standards Lisa Purcell, Sergeant Michael Ferguson, Corporal Robert Suddler and Corporal Melissa Turner.

Additional representatives from the Tampa Police Department Senior Assistant City Attorney Michael Schmid.

The Advisory Panel consisted of Albert Cooke, Lincoln Tamayo, Devon Ingandela, Irene Guy and retired Tampa Police Captain David Goodman. Panel members Carlos Valdes and Andrew March, were not in attendance

#### **VI. New Business**

Chief Lee Bercaw presented to the panel the department's recent advancements in technology, highlighting several key initiatives. These included:

- Implementation of Axon Policy Chat, an AI-based tool to support policy guidance
- Issuance of City cell phones equipped with vMobile, extending CAD system capabilities directly to officers' smartphones
- Deployment of real-time language translation through body-worn cameras
- Introduction of Virtual Reality training designed specifically for the newly issued TASER 10

In addition, Chief Bercaw informed the panel about the rollout of new outer carrier load-bearing vests to enhance officer comfort and safety. He concluded by sharing the department's goal of transitioning to Glock 45 pistols in the coming year.

Sergeant Michael Ferguson conducted the Tampa Police Department Emergency operations of Police vehicles, SOP 386. Sergeant Ferguson reviewed the training officers are provided with for Emergency operation of a police vehicle for purposes including driving in response to an emergency call for police service, police pursuits, and implementation of police intervention techniques.

Panel members then watched videos of officers involved in vehicle pursuits and training on police intervention techniques.

No panel members had any questions or additional input from the previous topic of the Tampa Police Department Communications presentation.


### **VIII. Future Meeting**
