

ORDINANCE NO. 2025- 98

AN ORDINANCE OF THE CITY OF TAMPA, FLORIDA, ESTABLISHING THE 2025 CITY OF TAMPA CHARTER REVIEW ADVISORY COMMISSION, IN ACCORDANCE WITH THE CITY OF TAMPA HOME RULE CHARTER OF 1975 AS AMENDED, SECTION 10.10; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 10.10 of the City of Tampa Home Rule Charter of 1975 as amended states:

Commencing in 2025, and every eight years thereafter, there shall be established by ordinance a Charter Review Advisory Commission (CRC) composed of nine (9) members; seven (7) members appointed by the city council, and two (2) members appointed by the mayor. It shall also have two (2) alternates appointed, one by the city council and one by the mayor. However, the city council may by ordinance, have the power to call for the establishment of a CRC more often in the event it so chooses. No members of the CRC shall be elected officials or city employees. Each member of the CRC shall be a city resident and elector. Vacancies on the CRC shall be filed within thirty (30) days in the same manner as the original appointment. Legal counsel, who is not a city employee, to provide legal advice to the CRC and a professional facilitator to facilitate the charter review process shall be engaged by the city with city council approval. Necessary funding shall be provided to ensure full transparency and citizen participation in the charter review process. The CRC may adopt other rules for its operation and proceedings, as it deems desirable, within the direction given to it by the city. The members of the CRC shall receive no compensation.

WHEREAS, a duly noticed public hearing as required by law was held by the City Council of the City of Tampa, Florida; and

WHEREAS, all citizens were afforded notice and an opportunity to appear and be heard at said public hearing.

NOW, THEREFORE,

**BE IT ORDAINED BY THE CITY COUNCIL
OF THE CITY OF TAMPA, FLORIDA:**

Section 1. That the 2025 City of Tampa Charter Review Advisory Commission (CRC) is hereby established.

Section 2. Appointment and Composition of the CRC:

The Charter Review Advisory Commission (CRC) shall be composed of nine (9) members; seven (7) members appointed by the City Council, and two (2) members appointed by the Mayor. It shall also have two (2) alternates appointed, one by the City Council and one by the Mayor. Vacancies on the CRC shall be filed within thirty (30) days in the same manner as the original appointment.

Section 3. Qualifications for Membership:

Each member of the Charter Review Advisory Commission shall be a city resident and elector. No members of the CRC shall be elected officials or city employees.

Section 4 Term of Members:

Vacancies on the CRC shall be filed within thirty (30) days in the same manner as the original appointment.

Section 5 Legal & Administrative Support:

Legal counsel, who is not a city employee, to provide legal advice to the CRC and a professional facilitator to facilitate the charter review process shall be engaged by the City with City Council approval. Necessary funding shall be provided to ensure full transparency and citizen participation in the charter review process.

Section 6 Appointment of members, legal counsel and facilitator shall be by resolution.

Section 7. Objectives and duties of the Charter Review Advisory Commission, and additional direction by City Council to the Charter Review Advisory Commission, if any, shall be by resolution.

Section 8. That should any part of this ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, the remaining provisions shall remain in full force and affect.

Section 9 That this ordinance shall take effect immediately upon adoption.


