REQUIRED REGISTRATON OR RE-REGISTRATION AS A GREASE

This serves as notice to you of the requirement to register/re-register as a Grease Hauler under the City of Tampa's Grease Management Ordinance #2006-288, effective November 21, 2006.

If you are currently registered with the City of Tampa, receipt of this letter confirms that your registration period is about to or has already expired. If you are not currently registered, you have been identified as a potential Grease Hauler with the City of Tampa, but our records reflect that you have not applied for and/or been registered.

Upon receipt of this letter, please contact the Sewer Service Inspectors Group at (813) 299-6300 or email darrio.davis@tampagov.net to notify us if you intend to apply for or register as a Grease Hauler with the City of Tampa. We are updating our list of the City of Tampa Registered Grease Hauler and will be providing this information to the Florida Department of Environmental Protection (FDEP), Hillsborough County Environmental Protection Commission (EPC), City of Tampa Food Service and Grease Disposal Sites.

Section 26-308 of the Ordinance prohibits any Grease Hauler from collecting, pumping, or hauling grease interceptor or trap wastes from businesses within the City limits without first registering with the City of Tampa. Any Grease Hauler found in violation of the Ordinance is subject to civil and/or criminal sanctions.

If you seek to register/re-register, enclosed is the Grease Hauler Registration Application Form. Please complete and mail the enclosed application to the attention of "Wastewater Department Utility Service" or drop it off at our office. Upon receipt of the completed application, the City has 45 days to review the application and respond in writing if the application has been approved, denied, or approved with conditions, and if any new vehicles will be scheduled for inspections.

Once approval is granted and the inspections are completed, new Grease Hauler decals will be furnished for your vehicles.
