The Board of Trustees of the City Pension Fund for Firefighters and Police Officers in the City of Tampa met on Tuesday, June 18, 2024 at 9:30 a.m. for a regular meeting with the following members present:

Additional participants included Dr. Bruce Bohnker, Medical Director; Dr. Mark Glencross, Medical Director; Mr. Robert Klausner, General Counsel; Mr. Mark Lenker, Fund Accountant; Mr. Christopher McRae, Disability Applicant; and active and retired plan members.

Public Comments: Pursuant to Florida Statutes, Section 286.0114(4), members of the public may comment on items requiring Board action, other than ministerial matters. Speakers are limited to two minutes each and not more than 20 minutes will be set aside for comments, without further Board approval. There were no public comments.

*Mr. Messmer noted per the 06/17/2024 addendum, the Fund had surpassed the \$3 billion market value threshold.*

1. Approved the minutes of the May 22, 2024 regular board meeting. **It was moved by Mr. Belmonte, seconded by Mr. Haintz and by unanimous vote to approve the minutes of the May 22, 2024 regular board meeting.**
2. Approved the minutes of the June 10, 2024 committee 2 meeting. **It was moved by Mr. Belmonte, seconded by Mr. Cannon and by unanimous vote to approve the minutes of the June 10, 2024 committee 2 meeting.**

Consent Agenda: Items on the consent agenda shall be acted upon in one motion. If an item requires additional discussion, that item shall be removed from the consent agenda for discussion. [Items 3 – 7]. **It was moved by Mr. Haintz, seconded by Mr. Cannon and by unanimous vote to approve consent agenda items 3 - 7.**

3. Ratified pension benefits.
4. Investment Management Report from Bowen, Hanes & Co. Inc. Noted receipt of the following:
  - a. Investment management report for the month ended 05/31/2024. Market value of investments was \$2,951,253,453.58 and the investment return was 21.7% on the total portfolio.

7. Noted receipt of Disability Process Timeline of disabilities in process as of 6/12/2024.

#### Medical Disability

8. Informal hearing for LOD disability applicant C. McRae, TFR. Noted receipt of disability application, qualifying letter, notice of injury reports, pre-employment physical, job description, sample letter to Medical Board, Medical Board reports, Medical Director's summary, medical records, and other documents related to the case.

Mr. McRae was sworn in and made a brief opening statement. Drs. Bohnker and Glencross were sworn in. Dr. Bohnker, Ms. Weber, and Mr. Klausner responded to a clarifying question regarding one of the doctor's IME reports. **It was moved by Mr. Haintz, seconded by Mr. Spearman and by unanimous vote that the Board finds there is a disability that occurred in the line-of-duty that permanently incapacitates Mr. McRae from the regular and continuous duties of a firefighter.**

**It was moved by Mr. Haintz, seconded by Mr. Spearman and by unanimous vote that the Board grant Mr. McRae a line-of-duty disability pension due to a back injury, retroactive to his last day on payroll.**

9. Approval of Final Order denying application of disability applicant D. Patricio, TFR. Following procedural comments from Mr. Klausner, **it was moved by Mr. Belmonte, seconded by Ms. Wynn and by unanimous vote to approve the Final Order denying application of disability applicant D. Patricio.** Mr. Klausner advised that the Final Order should be sent to both Mr. Patricio and his attorney, Mr. Leuzzi.

#### New Business

10. Noted receipt of listing of upcoming conferences. Disclosure of planned attendance, if any.  
Mr. Messmer clarified that only Ms. Wynn is attending the NCPERS Public Pension Funding Forum in Boston, MA. Mr. Haintz and Mr. Thiel both declared for the ValueEdge Public Funds Forum in Laguna Beach, CA. Ms. Weber noted that the Division of Retirement Conference in November was no cost to attend if any of the Trustees were interested.
11. Committee 2 report. Mr. Belmonte provided a recap of the meeting, noting that the committee recommended to retain all current professionals, but with a discussion to be held with the Chairman, Plan Administrator, and TGH to discuss ongoing issues concerning the transition of medical director services. Mr. Belmonte and Ms. Weber expanded on the details of the issues in question and discussion was held. **It was moved by Mr. Haintz, seconded by Mr. Rogero and by unanimous vote to accept the committee's recommendation and to allow the Chairman to act as a committee of one to commence a search for a replacement should the upcoming discussion with TGH be unsuccessful.**
12. Chair's call for any new business items from trustees to be placed on next agenda. None.
13. Chair's report. None.
14. Plan Administration. Ms. Weber reminded the Trustees that the July board meeting was canceled. She noted that the office was still receiving a few calls regarding non-payment of the 13<sup>th</sup> check. Ms. Weber was asked

what type of questions regarding the 13<sup>th</sup> check were still being asked, to which she responded and offered additional comments on the subject. She further advised that minor vandalism to the outside office property and that a police report had been filed.


16. Sanzone Small Claims Lawsuit Hillsborough County Circuit Court Case No.23-CC-019963


17. Vidovic Petition of Writ of Certiorari Hillsborough County Circuit Court Case No.24-CA-002860  
Mr. Klausner noted that the court has to issue an order to direct response to Ms. Vidovic’s petition, and to date, none had been received.


Securities Litigation Report – Update by attorney, if any. [Item 18]
