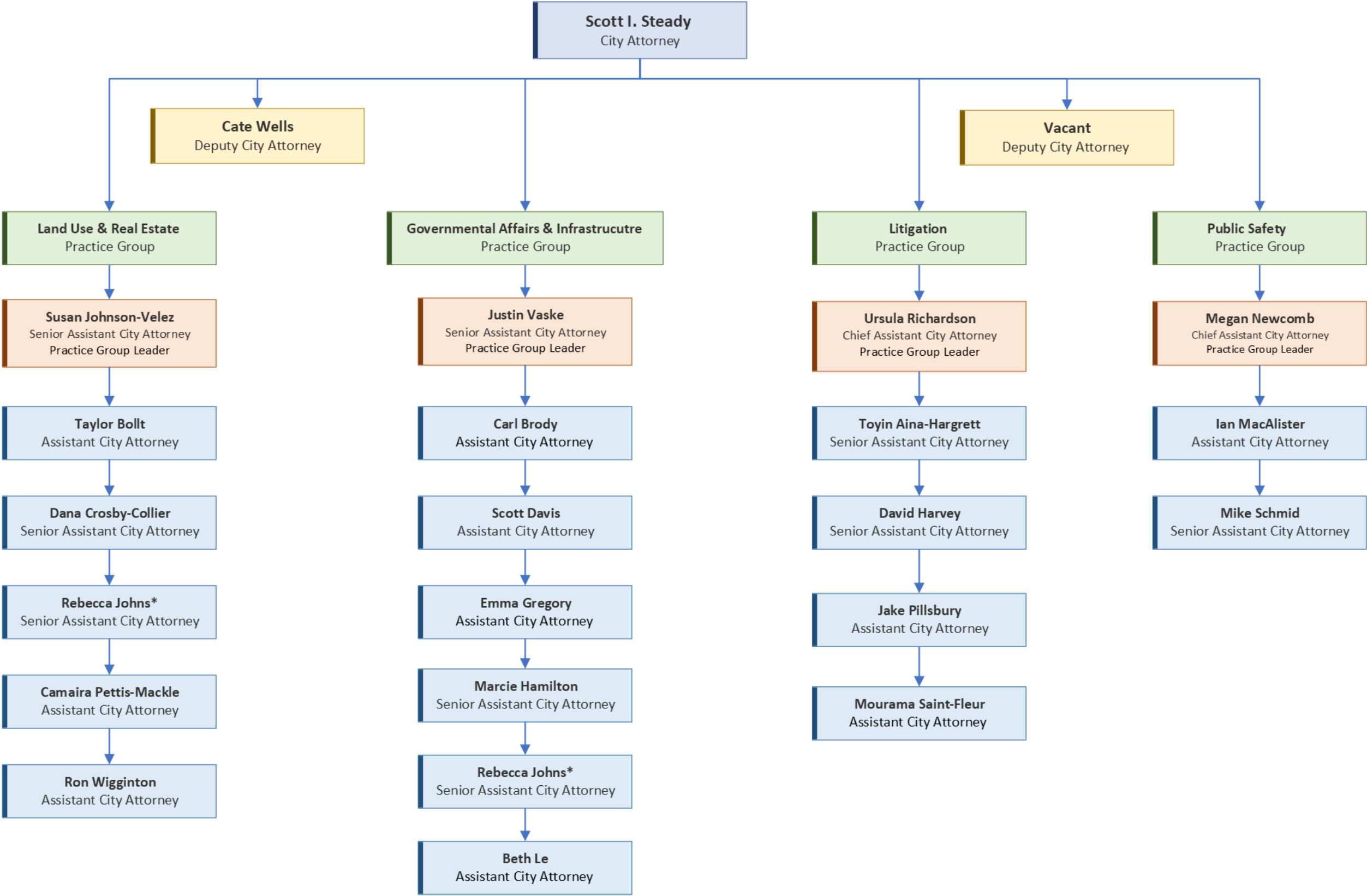


Organizational Chart
