

RESOLUTION NO. 2025- 1116

A RESOLUTION FORMALIZING AND MEMORIALIZING APPOINTMENTS TO THE 2025 CITY OF TAMPA CHARTER REVIEW ADVISORY COMMISSION (“CHARTER REVIEW COMMISSION” OR “CRC”) ESTABLISHED BY ORDINANCE NO. 2025-98, AND IN ACCORDANCE WITH RESOLUTION NO. 2025-1044; DESIGNATING THE FACILITATOR AND LEGAL COUNSEL TO THE CRC; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance No. 2025–98, passed and ordained by the City Council of the City of Tampa on September 18, 2025, established the 2025 City of Tampa Charter Review Advisory Commission (“Charter Review Commission” or “CRC”) in accordance with the City of Tampa Home Rule Charter of 1975 as amended, Sec. 10.10; and

WHEREAS, consistent with Resolution No. 2025-1044, Section 2, the Tampa City Council herein formalizes and memorializes the appointment of seven City Council-appointed members, two Mayoral-appointed members, and one alternate designated the City Council alternate, the other designated the Mayoral alternate. City Council herein designates the facilitator and legal counsel to the CRC, pursuant to the City Charter, Section 10.10, and Section 6 of said Resolution.


