







- Addition of a 6 ft. Concrete Sidewalk on west side





- Unfortunately, in order to widen Interbay Blvd., the 9 oaks on the north side of the road must be removed.
- On Interbay Blvd., no trees proposed to be removed on private property, all are within the right of way.




#### **Scope of Project – Tree Removals**



- On Manhattan Ave. south of Interbay Blvd., several oaks and smaller tree species will need to be removed to accommodate the improvements.
- A few of these are on private property. All property owners will be notified in advance of construction and throughout the construction process.





- Construction Cost:
  - Manhattan Improvements \$930,000
    - City of Tampa awarded 2020 Defense Infrastructure Grant (DIG) in the amount of \$340,000.
  - Tanker Way Right Turn Lane \$150,000
- Begin Construction TBD (based upon contractor availability)
- Construction duration 9 Months
