## RESOLUTION NO. 2025- (210)

A RESOLUTION APPROVING FORM OF AGREEMENT BETWEEN THE CITY OF TAMPA AND VARIOUS CONSULTANTS IN CONNECTION WITH PROFESSIONAL SERVICES TO BE PROVIDED ON A WORK ORDER BASIS; AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENTS; DESIGNATING HOW PAYMENT FOR THE WORK IS AUTHORIZED; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City, in compliance with the requirements of the Florida Consultants' Competitive Negotiation Act (Section 287.055, Florida Statutes), seeks to enter into agreements with various consultants to provide professional services for specifically funded projects, which will be executed on a work order basis; and

WHEREAS, in order to facilitate the hiring of said consultants on a word order basis, it is necessary to approve a standard Work Order Agreement for Professional Services As Needed, which requires City Council approval.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA:

<u>Section 1.</u> That the form of agreement entitled WORK ORDER AGREEMENT FOR PROFESSIONAL SERVICES AS NEEDED, or in substantially similar form, is hereby approved, being attached hereto and made a part hereof; and the City of Tampa is hereby authorized to enter into agreements utilizing said form, with those consultants listed on Exhibit A, attached hereto and by reference made a part hereof.

<u>Section 2</u>. That the Mayor of the City of Tampa is authorized to execute and the City Clerk of the City of Tampa to attest and to affix the official City of Tampa seal to the agreements for and on behalf of the City of Tampa.

<u>Section 3.</u> That work herein and hereby authorized shall be performed on a work order basis issued as needed to selected firms for individual projects or services, subject to approval by the responsible department director and shall be controlled by requisition from various funds. The maximum amount for any single work order under this agreement will not exceed \$200,000.

<u>Section 4.</u> That the proper officers of the City of Tampa are hereby authorized to do all things necessary in order to carry out the provisions of this Resolution, which shall take effect immediately upon its adoption.
